Minutes of the Board of Directors' Meeting February 20, 2025

CALL TO ORDER

The Board of Directors' Meeting of the Erie County Gaming Revenue Authority was held on February 20, 2025 in the Jordan Room; 5240 Knowledge Parkway; Erie, PA 16510. Legal Notice of the meeting was given through an advertisement appearing in the Erie Times-News. The meeting was called to order by the Chair at 8:34 am.

ROLL CALL

Ms. Amatangelo, Mr. Cleaver, Ms. Hess, Mr. Louis, Mr. Oberlander, Mr. Smith, and Mr. Winschel are present in person. Mr. Scutella and Mr. Copeland (begins meeting on zoom, then joins in person) are present in person. Mr. Wachter and Dr. Wood are present in person.

APPROVAL OF THE AGENDA

Mr. Oberlander makes a motion to approve the agenda. Mr. Louis seconds the motion. There is no discussion of the agenda. Motion carries 7-0.

APPROVAL OF MINUTES - January 2025

Ms. Amatangelo makes a motion to approve the minutes. Mr. Oberlander seconds the motion. There is no discussion on the minutes. Motion carries 7-0.

DIRECTOR'S COMMENTS

There are no comments from the board of directors at this time.

COMMENTS BY THE CHAIR

Mr. Cleaver has no comment at this time.

PUBLIC COMMENT

There is no one from the public present.

PRESENTATIONS

There are no presentations scheduled for today.

COMMITTEE REPORTS

a. Treasurer's Report

Ms. Amatangelo: I really didn't have any questions regarding the financials; I went over them with Perry and Tammi last week. The only thing I'll say is that the CD's are coming up.

<u>Dr. Wood</u>: Yes, two of them are due literally tomorrow for renewal, so we have a grace period there. I just met with the new CEO at Flagship, and they have some really competitive rates, so I think we're going to re-up there; so we'll keep the ladder going there. FNB – we're waiting to hear back from them on their rates, but we expect to hear from them today.

Mr. Winschel: Just be careful of that grace period because if you don't get it in time, they automatically renew at the lower rate.

Ms. Amatangelo: The only thing new was the Draft Budget; there was an increase for legal services and the annual 3% cost of living raise, but that was all for the financials. Does any director have any questions they want to bring up?

Mr. Winschel: I have a question on the budget and salaries, Perry. It went up like 10% and I just wonder why since the increase in wage is 3%.

Dr. Wood: That increase is a calculation on all three employees.

Mr. Winschel: But if you look at the budget item, isn't it . . .

Mr. Oberlander: It went up 9.4%.

Ms. Amatangelo: The entire budget did, yes.

Mr. Oberlander: No, just the Salaries and Benefits went up 9.4.

Mr. Winschel: So, the salaries went up three but what about the other 6%?

Ms. Michali: If you look at where we are on the Budget for this year, we are going to exceed the budget due to a miscalculation on my part. So, that increase is a fix from the undercalculation from last year plus the regular increase for this year.

Mr. Wachter: Does that line item also include health insurance?

Ms. Michali: Yes.

Mr. Wachter: What is the increase in health insurance this year?

Ms. Michali: I don't have that rate as of yet, since renewal isn't until May.

Mr. Wachter: So, you're predicting an increase not only in salaries in the salaries of \$7,500, which is 2.5 – 3% of the \$250,000, but there is an additional increase projected in there for benefits.

Mr. Cleaver: What is the date of approval for this draft? April 1st?

<u>Dr. Wood</u>: This is a draft; this is our first conversation. Next month would be the second conversation about it, but the third Thursday of March is when we approve it, and it's actually finalized. So, basically everything is flat other than legal fees, which we jacked up anticipating what we've just been through taking place another year, and then the 3%. Give us some grace on the health insurance stuff and we'll come back to you when we get a finalized figure from Highmark. Are there any other questions about the budget?

Mr. Wachter: With your increase in salaries, you should also double check an increase in the corresponding employment taxes.

Mr. Louis: Who is the broker you use for your health insurance? Do you work with a group?

Ms. Michali: Runsteadler Life.

<u>Dr. Wood</u>: We have this conversation every year. We can always look at other options but this particular group that we've used in the last three cycles has gotten us the best rate.

Mr. Louis: I know Highmark has a great product that is low cost for small groups. I was just curious.

Dr. Wood: Like a Highmark Direct product?

Mr. Louis: No, through the broker.

<u>Dr. Wood</u>: That's what we would run into when we would try to go direct, we're too small to get any attention.

Mr. Louis makes a motion to approve the Treasurer's Report. Ms. Hess seconds the motion. There is no discussion on the Treasurer's Report. Motion carries 7-0.

b. Strategic Planning Committee

<u>Dr. Wood</u>: There was no Strategic Planning meeting this month but we will be firing one up as we put out our recommendations for Special Events and any other discussion items we have. Renaissance Block is getting fired up and the Arts, Culture, and Entertainment grant is getting fired up. We'll be approving Special Events at the March Board Meeting, so you'll be getting the summaries for that.

c. Update from County Council

Chairman Scutella: I have nothing to at this time, unless somebody has a question.

<u>Dr. Wood</u>: Technically, Rock Copeland is our liaison now, if you want to ask him.

Mr. Cleaver: Rock, is there any comment? I apologize for overlooking you.

Mr. Copeland: No comments or concerns at the moment.

d. Update from County Executive's Office

Mr. Cleaver: We got an email from the County Executives rep, Mr. Sinnott, that said he wasn't going to be available.

REPORT OF THE EXECUTIVE DIRECTOR

<u>Dr. Wood:</u> Okay, just a couple of highlights here in the Executive Director's Report. We were asked to participate in a briefing on the budget; the Board was invited and Mark attended, the Infinite Erie breakfast on the government relations concept, where basically leaders of the community come together to hear about what the state budget looks like. To put it in context, they also wanted local funding sources to come in and talk as well. So, I went in and gave a speech about ECGRA's grant making, where we're currently at, what we're looking at in 2025, and answered any questions about that. I did highlight the Early Childhood industry initiative as part of that; folks are really excited about that in particular. So, we talked about the schedule of when the grants are coming out and the importance of locally controlled capital, things like local share gaming revenue.

Next is your monthly report on the activities of Kate & Co. Then you see a press conference announcement related to that Infinite Erie event I mentioned. We also had a meeting with Penn State Behrend to talk about our website. They have agreed to take us on as a client. We had a great conversation with Kathleen Noce. We talked about, what does the navigation look like compared to other websites in the Erie area that you're looking at? She did say that she thought it was a pretty robust, well thought out page, but that she could make further recommendations as part of a student/faculty project. We said we would absolutely take that help. So, we're excited about that and working with her to make things more navigable, especially in the documents page of our website, which right now is a list of items, as opposed to more of a searchable document vault. This is part of our commitment to radical transparency, and we're going to make that even easier for the user.

Are there any questions for me?

SOLICITOR'S REPORT

Mr. Wachter: I will hold my comments until the Executive Session.

OLD BUSINESS

Mr. Winschel: Maybe just an update on the audit.

Dr. Wood: An update on the audit? Absolutely. So, the auditors, I think we're in our eighth round of information requests from the auditors. The audit, as you might remember, started out as an examination of whether or not we were in compliance with the Economic Development Financing Law, the Gaming laws, and our charter as an organization in Erie County. Then it expanded into, "Now we're going to look at all of the resolutions that you did within the last two-year period." Great, we took care of that. "Now we're going to look at the finances approved in the last two-year period." Great, we took care of that. Then it turned into, by the way, this is the clause, anything else that we asked for clause, that I'm talking about now, because we completed the original audit within months. So, we're going on seven months now of this audit and the newest round of request was, "Let's take a look at everything Brenton Davis has criticized you for, and let's see if you're in violation of any of that." I kind of welcomed that; I appreciated that transparency. So, they said, "Let's take a look at the letter that he wrote," and so we provided that letter and we also provided our response to the Davis Administration. They were satisfied with those answers. Then they said, "Okay, let's go back 10 years and let's look at everything you've done for the last decade." And we said, "Okay, let's go back 10 years." So, we're now on, I think the final information, although the last three requests have said we're getting close to finishing.

But here's the thing, it's been a great walk down memory lane. We've done everything right and we're super excited about that. We all know what the finding is going to be – the finding is going to be that state law says you have to have certain financial disclosures on your website, which we did, but not to the satisfaction of certain politicians. And when we rectified that by putting literally everything on the website, the audit was already in motion. So that's where we're at. I don't know how you folks feel about it, but I'm glad we went through this exercise. I think it'll put some things to rest that have been lingering for a long time and I'm confident that the product will be something I'll be proud of and will also be thoroughly criticized by our political enemies as saying, "We told you so." So, looking forward to seeing the results of that.

I did ask, "When are we wrapping it up?" And by the way, these are professionals working on this. We've had good interactions with these professionals. Tammi, would you agree?

Ms. Michali: Absolutely.

<u>Dr. Wood</u>: Mary Klein, who's the head of the seven-member team that has been working on our audit for seven months; they are professionals. They have treated us with professionalism and we've reciprocated. They do anticipate it taking several months to write the final report, as well, anticipating somewhere around May that it would be completed. Any other questions about the audit?

Please note for the record that Mr. Copeland enters the meeting at 8:47am.

Mr. Winschel: So, the revenue side, they're looking at that?

<u>Dr. Wood</u>: We submitted the revenue numbers to them five months, six months ago, and they said, "Yeah, this is black and white; this is straightforward. Yes, it will be part of the report." I said, "Okay. Little More, please. Little more." No, nothing more than that, but we're good.

Mr. Cleaver: I have a question. Do we get, or you, get any report at all from the casino, in reference to anything as far as increase in revenue, loss in revenue, any comment whatsoever?

<u>Dr. Wood</u>: We don't have any contact with the casino, and I like it that way to be honest with you.

Mr. Cleaver: When you say you have no contact, it's whatever the County sends to us?

<u>Dr. Wood</u>: Zero. Our contact is with the Department of Revenue at the state. And of course, the way those funds operate is funds flow from the state to the county, and the county to us. We do have contact with the Department of Revenue just to make sure we're given the same numbers the county has. To rectify that, the woman who runs that department said, "You know what? I'll just send you the exact letter I sent to the county with all the data on it." It's perfect because we know exactly what the County knows, which helped us determine that the revenue figures were off.

Mr. Cleaver: Anything further in reference to that?

NEW BUSINESS

There is no new business to discuss.

ADJOURNMENT

Ms. Hess moves to adjourn. Mr. Oberlander seconds the motion. Meeting is adjourned at 8:51am.

In accordance with the Pennsylvania Race Horse Development and Gaming Act 42 of 2017, the Department is required to distribute quarterly the Local Share Assessment collected for interactive gaming and slots to the municipalities in which a licensed gaming entity is located. This distribution is based on the interactive gaming and slots local share assessment amount collected plus the slot machine license operation fee amount collected over Summit Township's budget limitation.

An ACH for the 4th quarter of 2024 payment in the amount of \$2,950,366.08 should be deposited in your bank account within 7 - 10 business days. This payment includes the slots local share assessment of \$397,000.13, the slot machine license operation fee of \$2,500,000.00, and the interactive gaming portion of \$53,365.95. Any reductions to the Gross Interactive Gaming Revenue (GIGR) and Gross Terminal Revenue (GTR) for promotional items is the result of the Gaming Bulletin 2015-01 and the Pennsylvania Supreme Court's April 28, 2014 decision in Greenwood Gaming and Entertainment Incorporated v. Commonwealth of Pennsylvania, Department of Revenue (90 A.3d 699 (Pa. 2014)).

Whereas, ECGRA is a subrecipient of the Erie County Coronavirus Local Fiscal Recovery Funds and these funds will be used to support the creation and expansion of childcare slots throughout Erie County;

Whereas, ECGRA has held public meetings with childcare facilities and has included the Early Learning Resource Center in these meetings to assess gaps and needs in the childcare development system;

Whereas, ECGRA will work with the Northwest Institute of Research to collect and analyze employment information necessary to makes awards and will make recommendations for funding to the ECGRA Board;

ECGRA Early Care and Education Educator Retention Award (ERA) Erie County Investing in Families

FINANCIAL AWARD GUIDELINES REQUEST and ATTESTATION FORMS Child Care Centers, Group & Family Child Care Homes

Purpose:

This award is designed to support Early Care and Education (ECE) programs who are serving families in Erie County. Priority for these awards will be targeted to Department of Human Services (DHS) ECE programs serving vulnerable or at-risk populations. If there are available funds, they may be awarded to programs who have Pre-K Counts (PKC), Head Start and Head Start State Supplemental (HS & HSSP), Early Head Start (EHS), and/or Private Academic Pre-School (PDE) certification. Provider must be STAR 2, 3, or 4 at time of application. Pre-K counts is considered STAR 4.

Overview:

The ERA Request Forms (PAGE A & Attachment 1) will collect staff-specific information in order for eligible ECE programs to pay awards to qualified owner/operators and teaching staff.

Important Notes:

All award funds are contingent upon the availability of ECGRA funds.

This application may be denied if it is not complete or the instructions have not been followed.

For any questions regarding the completion and submission of the ERA request, please contact the JAM Team Foundation at info@jamteam.org

General Provider Eligibility:

To be eligible for the ERA, an ECE program must meet the following requirements. Additional requirements are detailed by section.

- 1) The provider must be designated at and meet all Keystone STARS Performance Standards associated with a STAR 2 (or higher) designation.
- 2) The provider must maintain the STAR designation for which the provider received the ERA during the approval and payment phase of the ERA. If a STAR level move-down occurs during this process, the provider is no longer eligible for that award amount. It is expected that the provider is making a commitment to maintain the awarded STAR designation.
 - i) If a provider moves down to a STAR 2 or 3 prior to payment, the provider will be required to submit a new application.
 - ii) If a provider moves down to a STAR 1 prior to payment, the provider will no longer be eligible to receive payment.
- 3) The provider must hold a regular Department of Human Services (DHS) Certificate of Compliance. If a provider has a Provisional Certificate of Compliance, award funds may be available upon return to a full DHS Certificate of Compliance. PKC, HS, HSSP, EHS, or PDE certification may apply and will be awarded based on available funding.
- 4) The provider must have an agreement with Child Care Works (CCW) through the Early Learning Resource Center (ELRC). Furthermore, the provider must be willing to enroll a child who qualifies for subsidy, if space is available.
- 5) Providers who owe liens/liabilities to the commonwealth and/or federal government, including tax liabilities, will be suspended from Keystone STARS and will not be able to receive grants and awards until those liens/liabilities are fully satisfied and the program provides the ELRC a clearance certificate

issued by the Department of Revenue. Clearance certificates can be obtained at the provider's local tax office.

Award Timeline:

Due to limited funds, it is recommended providers complete and submit their application by 5:00 p.m. Friday, April 25, 2025. All completed grant documents as listed below should be emailed to: info@jamteam.org

- Attachment #1 ERA Excel Budget Workbook see Attachment's instructions for details

Guidelines and Compliance for the ERA Award

Non-compliance with any requirement of the Grant Agreement could result in the provider being required to return grant funds to ECGRA.

- All award funds are a one-time payment for those working directly with children and are not to be used to supplement the incomes of teachers.
- Funds attributed to this grant must be expended within <u>six months</u> of the Board approval date as specified in the signed Grant Agreement. Grants not expended must be returned.
- The provider must retain original documentation for all award expenditures for seven years and ensure the documented amounts match total expenditures as reported on the respective Attachment #1 ERA Excel Budget Workbook. Non-compliance will result in grantee being ineligible for future grants.
- Important: Any unexpended funds must be returned to ECGRA.

Payroll Tax Assistance

This grant will include the 7.65% employer portion of payroll taxes associated with the payments made to eligible staff included on Attachment #1. This amount will be calculated for you on Attachment 1 and should be included on the Attestation Page. Please ensure all Totals on all documents are the same.

Award Reconciliation/Closure

The completion of the respective attachments will directly tie the request and approval of the award funds to the reconciliation and approval of expended funds.

For grant closing and budget approval/expense reconciliation, the following <u>must</u> be completed and submitted to info@jamteam.org no later than November 30, 2025.

Right to Know Law

Federal funding and local share gaming revenue (State funding) is being used as a source for the program funding. As such, Erie County, the U.S. Department of the Treasury, or their authorized representatives shall have right of access to records of the grantee to conduct audits or other investigations. Grantee records including the grant application, may be subject to disclosure under Pennsylvania's Right to Know Law.

Electronic Submission:

Attachment #1 ERA Excel Budget Workbook with all tabs completed.
 (The budget revision tab is to be completed only if budget revision becomes necessary).

Providers <u>must</u> keep documentation of ERA pay-outs to staff for their records, for review by the Jam Team Foundation or ECGRA and for state/federal agents who may need to review documents for auditing/monitoring purposes. **All grant related documents must be maintained for 7 years.**

- Allowable documentation: Payroll/employee compensation documents indicate payee, date, amount paid and description of payment and/or is supported by a check or other proof of employee payment.
- Payroll documents should remain onsite and should not be submitted with Attachment #1.

Examples of Unallowable Documentation

The following is a listing of documents that are unallowable as confirmation of a receipt or invoice:

- Copies of general ledger posting records.
- Copies of check registers or listing of checks written by providers.
- Computer accounting record screen-shots or other lists of data indicating payment.
- Documents that do not indicate payee, date, amount paid and description of payment and/or is not supported by a check or other form of payment.
- Documents that appear to have been altered or changed in any way.

Eligible Staff Persons

To be eligible, staff must be listed and verified on the providers staff report in the PD Registry. The following staff positions are eligible for this award:

Position Titles:

- OO = Owner/Operator as Primary Caregiver;
- PSP = Primary Staff Person as the Operator
- D/AD = Director and one Assistant Director
- GS = Group Supervisor
- AGS = Assistant Group Supervisor
- A = Aide

 Administrative, custodial, transportation, food service staff, and volunteers are not eligible for the ERA unless they have a minimum of a Child Development Associate (CDA) and work at least 15 hours per week directly with children. If this is the case, they should be classified as an Aide or AGS.

ECE Educator Retention Award (ERA) Award Amounts

Educator Retention Award (ERA): Staff awards are tiered to the program's STAR level, hours worked and Career Pathway Level. Hours are calculated on the average number of hours the staff person worked for the past 12 months. Please refer to the table below.

The intent of the ERA is to assist providers in establishing a stable workforce as they work toward higher levels of quality by reducing turnover and improving the education of teaching staff. To be eligible, a provider must meet site-specific requirements as well as staff-specific requirements.

ECE Provider Eligibility Requirements

The **provider** must meet the following site-specific requirements:

- Be able to provide the following upon request:
 - o Copies of employee salary scale, bonus policy and personnel handbook
 - o Proof of payment of payroll taxes
 - o Verification of staff eligibility through Career Pathway Placement in the PD Registry.
- ERA funds must be processed through payroll and are subject to applicable taxes (processing through IRS 1099 is prohibited). Adhere to IRS guidelines for employers and be responsible for any employer's portion of taxes as awards are distributed.
 - o If a legal entity is a limited liability corporation (LLC) and must file a Schedule K-1, they must also submit a 1040 Form to document that the appropriate taxes are being paid.
 - o For a group provider that files taxes with a Schedule C, they must also submit a 1040 Form to document that the appropriate taxes are being paid.
 - To prevent financial penalties to the provider from the US Department of Labor, providers are required to use all salary given to a staff person <u>including ERA funds</u> to calculate hourly rate of pay for over-time.

ECE Educator Eligibility Requirements

- **Staff** must be employed at the same legal entity for at least 12 consecutive months prior to the date of ERA request.
- Teaching staff awards may be used only for staff who work directly with children during operating hours (at least 15 hours) a week.
- Award amounts are based on the number of hours worked. Staff members working less than 15 hours per week are not eligible for awards. This may be an average of 15 hours over a 12 month period.

Academic Eligibility Requirements

Please refer to the Career Pathway on the PA Key website for clarifications regarding degree types, related degrees, credit hours, etc.

- Owner/Operator Awards
 - o At least a Level B on the Career Pathway
 - Can receive the director ERA at Career Pathway A+ with an approved educational plan to achieve Career Pathway Level B
- Teaching Staff Awards
 - o At least a Level A on the Career Pathway
- Teaching staff who are below Level A are not eligible.
- Administrative, custodial, transportation, food service staff, and volunteers are *not* eligible for the ERA.

Reporting Requirements

A closeout report will be required at the completion of the program. Details will be furnished at a grantee award meeting.

ECGRA must submit quarterly reports to Erie County. Grantees will need to furnish the following information:

- 1. Number of households served
- 2. Number of children served
- 3. Race, ethnicity, gender, and income level of families supported.

SEVENTH AMENDMENT TO AGREEMENT OF LEASE

This SEVENTH AMENDMENT TO AGREEMENT OF LEASE (this "Amendment") is made as of the 1st day of April 2025, by and between THE PENNSYLVANIA STATE UNIVERSITY a state-related institution and instrumentality of the Commonwealth of Pennsylvania subject to the Pennsylvania nonprofit corporation laws, located at 208 Old Main, University Park, Pennsylvania 16802 (the 'Lessor'), and the ERIE COUNTY GAMING REVENUE AUTHORITY, having an address at 5340 Fryling Road, Suite 201, Erie, Pennsylvania 16510 (the 'Lessee').

BACKGROUND

- A. Lessor is the fee simple owner of certain parcels of real property situate in Erie County, Pennsylvania, commonly known as Knowledge Park.
- B. The parties entered into an Agreement of Lease dated May 22, 2015 for 1,135 square feet of commercial office space on the second floor of 5340 Fryling Road, Suite 201 in Knowledge Park Building #4, which was amended by the parties (i) on September 15, 2017, to extend the Term to May 31, 2018 (the "First Amendment"), (ii) on May 1, 2018, to extend the Term to May 31, 2019 (the "Second Amendment"), and (iii) on April 17, 2019, to extend the Term to May 31, 2021 (the "Third Amendment") and (iv) on June 1, 2021, to extend the Term to May 31, 2022 (the "Fourth Amendment"), (v) on June 1, 2022, to extend the Term to May 31, 2023 (the "Fifth Amendment"), (vi) on June 1, 2023, to extend the Term to March 31, 2025 (the "Sixth Amendment") (as previously amended, hereinafter referred to as the "Lease").
- C. The parties now desire to amend the Lease to further extend the Term of the Lease to March 31, 2026 all on the terms and conditions set forth herein.

TERMS OF AGREEMENT

NOW, THEREFORE, in consideration of the mutual promises and covenants hereinafter set forth, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, the parties hereby agree as follows:

- 1. The Term of the Lease is hereby extended from April 1, 2025 until March 31, 2026 (the "Seventh Extended Term"). The Seventh Extended Term shall be governed by all of the terms and conditions of the Lease.
- 2. Commencing April 1, 2025, the Base Rent during the Seventh Extended Term shall be \$21,564.96 annually, payable in monthly installments of \$1,797.08 per month.
- 3. All provisions of this Amendment shall be effective as of the date hereof. Except as modified herein, all other terms and conditions of the Lease shall remain unchanged and

in full force and effect and the Lease in all respects is hereby ratified and affirmed by each of the parties hereto.

- 4. This Amendment shall be binding upon and inure to the benefit of the parties hereto, and their successors and permitted assigns. The Lease and this Amendment represent the entire agreement of the parties with respect to the subject matter hereof and supersedes all prior agreements with respect to such subject matter, whether written or oral.
- 5. Each capitalized term which is not defined by this Amendment shall have the meaning given to such capitalized term in the Lease. Unless otherwise indicated in this Amendment, all section and article references in this Amendment refer to the Lease.
- 6. The validity, interpretation and construction of this Amendment shall be governed by and construed in accordance with the laws of the Commonwealth of Pennsylvania without giving effect to any choice or conflict of law provision or rule (whether of the Commonwealth of Pennsylvania or any other jurisdiction) that would cause the application of the laws of any jurisdiction other than the Commonwealth of Pennsylvania.
- 7. This Amendment may be executed in one or more counterparts, each of which shall be deemed to be an original, but all of which shall be one and the same document. The parties agree that this Amendment may be executed by means of electronic signatures and that each copy to which such electronic signatures are affixed shall be deemed to be an original.
