Bridgeway Capital is pleased to provide this Performance Report on the Erie County Gaming Revenue Authority's 2018 Mission Related Investment of \$2.5 million for the Erie Inclusive Fund. To complement ECGRA's funding, which is being directed to minority-owned businesses in Erie County, Bridgeway has committed an additional \$2.5 million in capital from other sources to finance nonminority-owned businesses.

Since receiving launching the program in December 2018, Bridgeway has deployed 23 loans totaling \$3,321,464 to small businesses and nonprofits operating in Erie County. Program accomplishments to date include the following:

- \$1,392,944 has been lent to 14 minority-led enterprises.
- \$1,129,355 has been lent to 9 woman-owned businesses.
- \$1,928,520 has been lent to 9 non-minority-led enterprises (\$500,000 of which went to Erie Center for Arts and Culture).
- 14 of the 17 funded companies are located in The City of Erie and operate in low- to moderateincome areas; the other companies are 1 Tagteam Logistics, which is located in McKean; Perry's Pet in Waterford; and Rushin Enterprises based in Corry. All loans are in Erie County.
- To date, the Inclusive Erie Fund has supported the creation of 45 new full-time jobs.

During this reporting period, Bridgeway deployed the following 5 loans through the Erie Inclusive Fund.

- AAKA Imports, owned by a U.S. Citizen and immigrant entrepreneurs, operates a convenience store in the City of Erie.
- Northwest PA K9 Search and Rescue received a loan to purchase commercial real estate for this nonprofit group dedicated to assisting public safety agencies to find missing people. The property is located in Waterford, PA in Erie County.
- Dovetail Landing received a working capital loan to support their start-up of a wedding and event center located in Corry, PA in Erie County.
- Flagship Outdoor Services is a start-up landscaping and construction business. The business will hire 3 workers who will be paid a livable wage of \$20/hour. The business is located in The City of Erie.
- Sarah Jacobs, who participated in Bridgeway's ErieMade Creative Small Business Incubator program, received a working capital loan to increase sales and, it follows, revenue.

Bridgeway thanks ECGRA for its continued support of our efforts to stimulate economic opportunity and equitable development in Erie County. The small businesses and nonprofits that receive loans through the Erie Inclusive Fund are bringing exceptional services and economic activity to Erie County.
