# Erie County Gaming Revenue Authority

Minutes of the Board of Directors' Meeting November 19, 2021

Meetings for the Board of Directors of ECGRA can begin meeting in a physical location per Governor Wolf's proclamation of June 11, 2021. However, each member and ex-officio has the option to attend in person or virtually. Members of the public can now speak at the physical location of 5240 Knowledge Parkway.

### CALL TO ORDER

The Board of Directors' Meeting of the Erie County Gaming Revenue Authority was held on November 19, 2021 at 5240 Knowledge Parkway, Erie, PA 16510. Legal Notice of the meeting was given through an advertisement appearing in the Erie Times-News. The meeting was called to order by the Chair.

#### ROLL CALL

Mr. Barney, Mr. DiPaolo, Ms. Hess, and Ms. Loll, are present via Zoom. Mr. Cleaver and Mr. Paris are present in person. Mr. Wachter and Mr. Lee are present via Zoom, and Dr. Wood is present in person. Mr. Sample joins the meeting late via Zoom.

#### APPROVAL OF THE AGENDA

Mr. Cleaver makes a motion to approve the agenda as presented. Mr. Paris seconds the motion. There is no discussion of the agenda. Motion carries 6-0.

#### APPROVAL OF MINUTES - October 2021

Mr. Cleaver makes a motion to accept the minutes. Mr. Paris seconds the motion. There is no discussion on the minutes. Motion carries 6-0.

#### DIRECTOR'S COMMENTS

<u>Mr. Paris</u>: I was just curious on what everyone thought about the zoo losing its accreditation and if we should kick them out of the Lead Assets. What do you think? I was just wondering if there may be

any ramifications down the road. How did this happen, and is this something we should be concerned about?

<u>Mr. Barney</u>: I agree that we need to discuss it and how it occurred, but I wasn't leaning all the way toward kicking them out of the Lead Assets. It is definitely something to discuss. What are the feelings of others?

Ms. Hess: I think I would need way more information, personally, before I would have an opinion.

Mr. DiPaolo: I would also.

<u>Mr. Paris</u>: That's all I had; I was just curious.

<u>Mr. Barney</u>: I think we'll be talking to them in the near future. There will be some discussion with the Lead Assets on the Lead Assets. Dr. Wood, what is your opinion? Do you have any comment?

<u>Dr. Wood</u>: I saw it on the news last night with everyone else. What is the weight of zoo accreditation at the end of the day? I don't really know. It seems like a black eye. From a legal standpoint, I don't think there is anything in the Settlement Agreement that says, "Thou shalt remain accredited" clause.

<u>Mr. Wachter</u>: Perry, I would agree. There is nothing in there that says that. I would also note that my knowledge of the accreditation process is such that that if you are accredited and you receive some funding from the Commonwealth of Pennsylvania, then you are not subject to the Pennsylvania Game Commission regulations regarding zoos and that is why it is important for these zoos to be accredited. The Game Commission regulations were drafted, I think, in the 50's, and they are very outdated.

<u>Dr. Wood</u>: Game Commission, not Gaming Commission. Those are two very different things.

<u>Mr. Wachter</u>: It's more of an operational issue for the zoo rather than anything else.

<u>Mr. Barney</u>: Thank you. Are there any other Directors who have anything to say?

<u>Ms. Hess</u>: I do, Dale. I just wanted to share with everyone that I participated in several of the Jefferson Society presentations over the last couple of weeks. It was really good and I think it is a really important service and the money that we provide the Jefferson Society produces really good programming. I just wanted to share that with everyone that there were some really good programs that we supported. That's all I have.

# COMMENTS BY THE CHAIR

<u>Mr. Barney</u>: I concur, Kelly. I had the opportunity to attend quite a few of them and I thought they were top notch.

# PUBLIC COMMENT

There is no public present.

### PRESENTATIONS

There are no presentations scheduled.

### COMMITTEE REPORTS

a. Treasurer's Report: <u>Mr. Cleaver</u>: Thank you, Mr. Chairman. I reviewed all the expenses, the Profit & Loss, with Dr. Wood and everything seems in order and we are well within our budget. There is one item that I do want to bring up and for Dr. Wood to explain. We do have what they call Interactive Gaming Revenue; it's an additional revenue that we received and I'll turn it over to Perry and let him explain where that came from. It's a plus on our side. Other than that, I have nothing to report, Mr. Chairman.

<u>Dr. Wood</u>: I will explain this briefly. Typically, we have only had one category of revenue, and that was Gaming Revenue which is revenue that came from slots. Now there is a new form of revenue called Interactive Gaming Revenue which is only a couple of years old. There was a large cash payout of \$1.9 million, which is our share after the County takes their half and we decided to recognize it because, while it is subject to the Settlement, it is immediately unrestricted as opposed to having to wait twelve months for the funds to become unrestricted like we have to do with slots revenue. It is similar but has that one distinction. I'll see if Tim has anything to add because Tim is the one who helped me come to this conclusion after reviewing the legal side.

<u>Mr. Wachter</u>: This is like a true-up payment. The way that this works with Interactive Gaming is that the State has set a base year of 2017-2018 and they measured the amount of money that each county had received from the Local Share slots revenue and then they determine when they put the Interactive Gaming in that that was going to impact the amount of slots money received. So, then this payment is a true-up to take us from where we were with slots in 2017-18 and truing it up using the Interactive Gaming Revenue. It is specifically to be spent on that category of municipal projects that we typically spend our money on. So, this is making up for lost money, which is great.

Mr. Barney: Thank you. Are there any questions of the Finances?

Mr. DiPaolo makes a motion to accept the Treasurer's Report as presented, with Dr. Wood's explanation of interactive gaming. Mr. Paris seconds the motion. There are no questions or discussion of the Treasurer's Report. Motion carries 6-0.

The internet service in the building at Knowledge Parkway has been unstable and now has been disconnected. The meeting continues via Mr. Paris's personal cell phone. The minutes from here on out are a summary of the statements that were made.

b. Strategic Planning Committee: Dr. Wood states that there was a meeting held last week via Zoom to discuss the applications for the Community Centers, of which there were 16, and the Multi-Municipal Collaboration, of which there was only one. The consensus that was reached at that meeting is shown in resolution form in both Resolution Number 15, 2021 and Resolution Number 16, 2021 that will be voted on later in the meeting.

- c. Update from County Council: Mr. Anderson is not present to give an update.
- d. Update from County Executive's Office: Mr. Lee wants to reiterate what Ms. Hess stated earlier about the caliber of the Jefferson Educational Summit that was held over the past two weeks. Mr. Lee was able to attend the session with former President George Bush and felt that it was outstanding. He stated that it is not often that Erie, PA has the opportunity to sit in and listen to a former President of the United States speak. Not only that event, but all the others, shows the outstanding quality of programming we have available to us.

Mr. Lee then proceeds to talk about the 2022 County budget having been submitted to the County for review. The amount of the budget is \$534.24 million and County Council will have until the end of the month to make a decision on that budget.

Next, Mr. Lee talks about the ARPA money that has been made available and that the \$26.2 million has been set aside for the 2022 budget, in which ECGRA will have a part, to administer the Transformative Grants.

Dr. Wood asks Mr. Lee to clarify that ECGRA is indeed in the budget for 2022, and if so, how much would ECGRA be receiving. Mr. Lee confirms that ECGRA will be receiving money in 2022 for the Transformative Grants but does not have a specific number. He tells Dr. Wood to get in touch with James Sparber to confirm the actual amount.

Mr. Lee then gives an update on the 2021 Summer Jobs Program and explains that the final report of the outcomes is in process by Keystone Research and as soon as that report is completed, he will submit it to Dr. Wood who can make it available to all Board members.

# REPORT OF THE EXECUTIVE DIRECTOR

Dr. Wood begins by talking about the status of ECGRA's application for the ARPA funding in the amount of \$4 million for Transformative Grants. He tells that Board that paperwork has been signed and submitted but we are waiting for some feedback at this time. The basic model of the Transformative Grants is to focus on areas like entrepreneurship and small business, placemaking, and community facilities. He reiterates that ECGRA did submit the first draft of the application and that the process is moving along. Dr. Wood asks for questions and there are none.

Dr. Wood directs everyone's attention to the report in their documents and references the letters of thanks and the various news clippings that pertain to ECGRA. But he notes that the main document in his report is the report of the COVID-19 Committee. He is very pleased that Erie County has a document like this that highlights several different types of organizations and the impact that COVID may have had upon each one. He explains that this document will be very helpful to ECGRA in moving forward with the Transformative Grant program because it helps clarify where the needs are strongest.

Dr. Wood explains that the report is broken down by categories and each category has three sections; they include Highlights – which tells who was involved in the discussions about that particular topic, Findings – which tells what had been discussed and what the perceived needs were, and finally Recommendations – which is the results and ideas of how to best move forward.

Dr. Wood confirms how productive these meetings were and recognizes the members of the committee for their great communication, interaction, and support of such a timely topic. Dr. Wood asks for questions and there are none.

# SOLICITOR'S REPORT

Mr. Wachter states that he was only going to discuss the Interactive Gaming, but since Dr. Wood already did, he has nothing to discuss.

### OLD BUSINESS

There is no old business to discuss at this time.

#### NEW BUSINESS

a. Resolution Number 15, 2021 – Resolution to enter into agreement with one (1) entity as the sole recipient of the 2021 Multi-Municipal Collaboration Grant, Round 2.

Dr. Wood reads the resolution.

Mr. Paris makes a motion to accept the resolution. Mr. Cleaver seconds the motion. There is no further discussion of the resolution. Motion carries 6-0.

Mr. Sample joins the meeting via zoom on Mr. Paris's cell phone.

 Resolution Number 16, 2021 – Resolution to enter into agreements with thirteen (13) Erie County community organizations and municipalities engaged in Community Centers as part of the Community Assets.

Dr. Wood reads the resolution.

Mr. Sample makes a motion to accept the resolution. Ms. Hess seconds the motion.

Mr. DiPaolo notes that he will have to abstain from voting on this resolution as he is on the Executive Board of the Eagle's Nest Leadership Corporation, who is one of the grantees receiving funds. Mr. Wachter is asked to prepare and submit a Conflict of Interest Memo for Mr. DiPaolo.

There is no further discussion of the resolution. Motion carries 6-0-1, with Mr. DiPaolo abstaining.

#### ADJOURNMENT

Ms. Paris moves to adjourn. Mr. Sample seconds the motion.

Whereas, the Economic Development Financing Law expressly states that entities like ECGRA have as a purpose to "promote industrial, commercial and other economic development"; and,

Whereas, ECGRA's Strategic Plan calls for an economic development approach that targets small business financing that creates jobs, bridges gaps in the current ecosystem, supports demographic groups underrepresented in business ownership, leverages other sources of funding, both public and private, and develops entrepreneurial services in the form of technical assistance; and,

Whereas, in accordance with ECGRA's impact investment policy and by the recommendation of the strategic planning committee, ECGRA seeks to establish a Community Enterprise Financing Loan by authorizing the executive director and solicitor to negotiate and execute on terms and conditions in order to effectuate mission-related investment;

NOW THEREFORE, BE IT RESOLVED that the Board of Directors of the Erie County Gaming Revenue Authority, pursuant to the Economic Development Financing Law and the ECGRA Bylaws, establishes the Community Enterprise Financing Loan not to exceed \$1,000,000 subject to contract negotiations with the executive director and legal counsel, and to serve as a guide to update ECGRA's Economic Impact Investing Policy.

# **MISSION RELATED INVESTMENT**

### **COMMUNITY ENTERPRISE FINANCING LOAN**

**Purpose**: Community-based nonprofits offering a new service via contracts or grant funding are often underfunded and lack sufficient cash flow. Startup and operational costs are needed for these nonprofits to behave in an entrepreneurial fashion. ECGRA proposes creating a low-cost loan product to eligible applicants to cover start up and operational costs incurred because of a grant or service contract to provide a community enriching program. This fund is to assist these established community-based entrepreneurs in providing upfront and startup capital to fund these new initiatives. It is not designed to replace traditional bank financing. The amount dedicated to this program by ECGRA shall not exceed \$1,000,000.

**Eligibility**: Erie County, nonprofit entities that have obtained grants or contracts to provide a new and/or necessary community program but don't have adequate cash flow to fund start up and current operation costs. This loan focuses on entities that do not currently have the collateral for bank financing and/or are not eligible for an approved line of credit from a lender.

**Terms**: Short term, no interest loans. Term not to exceed 18 months, or the term of grant funding or contract, whichever is shorter. 90–180-day payment free period. Multiple drawdowns may be authorized, not to exceed total loan amount. Bi-annual payments, thereafter, amortized over total period of term or as otherwise negotiated. Balloon payment on backend. Terms negotiated via the executive director with the solicitor's feedback.

**Risk/Security**: To mitigate risk, the revenues from grant or service contract would be assigned to ECGRA. Note that many government grants may prohibit the assignment of grant funds. As such, there may not be an opportunity for assignment. Under these circumstances, ECGRA would include in any agreement that failure to repay the loan would place the nonprofit in a perpetual state of ineligibility for future funding. Furthermore, the drawdown schedule would be based on the individual grant reimbursement process and associated timeline. Since this varies by grant, the terms would be negotiated by the executive director in consultation with the solicitor.

Application Fee: 1.5% of each disbursement to recoup administrative costs.

#### Project Summary (50 words):

Install 73-miles of high-speed, optimized fiber optic network connected to low-latency fiber node to Tier 1 carrier. Expandable network to every business (50 Mbps to 100 Gbps symmetrical

via dedicated fiber) and household (25 Mbps up to 1,000 Mbps/1 Gbps symmetrical speeds) within the City of Corry.

### Detailed Project Description: (300 words max)

This is an all-fiber PON network designed upon a nodal architecture, (upgradable to NG-PON2 to supply up to 10GB/address) using middle-mile fiber to the Corry Area Technology Center and Hub (CATCH) as a nodal distribution location for final-mile fiber-to-the-premise. Network will deliver voice, internet, video, and WAN services. End user services will be delivered through the ONU. Client connections are delivered using a x32 split ratio for the PON network. Within the design criteria, each splitter (x4 or x8) within network is deployed with a minimum of one port unallocated at the initial construction and client connections. Within the distribution layer of the fiber network, a minimum of two strands of fiber are unallocated for future growth and new commercial and residential construction within the service delivery area. The initial network is being deployed with the nominal splitting of x21 once all unused ports are accounted. With a nominal internodal connection of 160GB, end user service limitations due to oversubscription are removed. Using forward facing real-time analytics, peak usage metrics will be examined and upon triggering events as determined within the operational metrics, additional internodal and tier carrier bandwidth will be added as needed. The network source, Corry Area Technology Center & Hub (CATCH), will be a thriving regional economic and education powerhouse, that will be accessible to all residents as soon as they are connected through this project's high-speed, fixed fiber network. Deployment clears a secondary exclusionary challenge to equitable access: affordability. Responsive to the challenge of 17.4% of residents living in poverty, service packages begin at \$25/month for voice and 25mb symmetrical services for households and \$65/month at 100mb symmetrical for businesses. Household service fees top out at \$130/month for 1 Gig/500Mb and \$300/month for 1 Gig symmetrical for businesses.

# Project Impact/Importance: (300 words max)

Corry's fiber network will transform every home into a potential virtual business or remote worker office and still offer the bandwidth for online learning, training, and re-training. Partnerships with the Corry Higher Education Council and numerous regional colleges will offer training for numerous professions and technology-based careers. 2018 U.S. census data shows that the most common jobs in Corry are manufacturing (714), retail trade (416), health care and social assistance (392), educational services (229), and accommodations and food services (172). Of this group, only manufacturing ranks among the top five highest paying professions at an average annual income of \$35,789 annually, \$5,156 less than the average median income. Access to training and remote work will create information jobs, which are currently the highest paying jobs in Corry with median earnings of \$81,429, which currently comprise 3.82% of the Corry workforce. There would be a corresponding rise in computer and mathematical services; professional, scientific, and technical services; and other related, professions with increased earning potential. Universal fiber network implementation within the City of Corry is step one of multiple step process to build largescale fiber network through rural communities of Erie and contiguous counties. These efforts will create a large network through which educational, work, and training opportunities will flow to rural residents. This network will make each participating community more attractive for residents and businesses, more self-sustaining, and better integrated into the workforce development ecosystem for our region. Step two of this process is universal fiber implementation to unserved and underserved census blocks through the Union City and Corry Area School Districts within Erie and Crawford Counties. A \$6.3M request to begin to build this system in public/private partnership with the Commonwealth of Pennsylvania is currently in review with the National Technology and Information Agency's Broadband Infrastructure Program.
