Minutes of the Board of Directors' Meeting September 15, 2022

Meetings for the Board of Directors of ECGRA can begin meeting in a physical location per Governor Wolf's proclamation of June 11, 2021. However, each member and ex-officio has the option to attend in person or virtually. Members of the public can now speak at the physical location of 5240 Knowledge Parkway.

CALL TO ORDER

The Board of Directors' Meeting of the Erie County Gaming Revenue Authority was held on September 15, 2022 at 5240 Knowledge Parkway, Erie, PA 16510. Legal Notice of the meeting was given through an advertisement appearing in the Erie Times-News. The meeting was called to order by the Chair.

ROLL CALL

Mr. Barney, Mr. Cleaver, and Mr. Oberlander are present in person, Mr. DiPaolo, Ms. Hess, and Mr. Winschel are present via Zoom. Mr. Smith is present via Zoom (joins late). Mr. Wachter and Dr. Wood are present in person.

APPROVAL OF THE AGENDA

Mr. Cleaver makes a motion to approve the agenda. Mr. DiPaolo seconds the motion. There is no discussion of the agenda. Motion carries 6-0.

APPROVAL OF MINUTES - August 2022

Mr. Cleaver makes a motion to accept the minutes as presented. Mr. Winschel seconds the motion. There is no discussion on the minutes. Motion carries 6-0.

DIRECTOR'S COMMENTS

<u>Dr. Wood</u>: Bob, this is just an open period when anyone on the Board can bring up any issues.

There are no comments by any Board member at this time.

COMMENTS BY THE CHAIR

Mr. Barney: I would just like to take the opportunity to welcome Bob Oberlander to the Board and I look forward to doing some great and prosperous things together.

PUBLIC COMMENT

There is no public present for comments.

PRESENTATIONS

There are no presentations at this time.

COMMITTEE REPORTS

- a. Treasurer's Report: Mr. Cleaver: Thank you, Mr. Chairman. I reviewed the Treasurer's Report, the income and expenses, and everything is in order. There was one item that I questioned, and it was that the auditor's fees are overspent; everything else is in line. If you have any questions, I'm sure that they can be answered. Other than that, that is the end of the report.
 - Mr. DiPaolo makes a motion to accept the Treasurer's Report as presented. Ms. Hess seconds the motion. There are no questions or discussion of the Treasurer's Report. Motion carries 6-0.
- b. Strategic Planning Committee: There was no meeting held so there is nothing to report.
- c. Update from County Council: Mr. Shank is not present to give a report.
- d. Update from County Executive's Office: Mr. Smith has nothing to report once he joins the meeting.

REPORT OF THE EXECUTIVE DIRECTOR

<u>Dr. Wood</u>: Thank you, Mr. Barney. You'll see in the Executive Director's Report that the first document is the letter showing that Q2 revenue came in. Just a reminder, our revenue comes in from the State quarterly, it goes to the County finance department, the finance department has a formula for distribution which involves putting a certain amount of dollars into the land bank and then putting the remainder of that half with ECGRA. This is the official letter you see here with the justification of

the documentation we get before we get the wire transfer from the County finance department with their little scribble calculation down in the right corner.

Next you will see a memo here from both the County Executive and one from Councilman Bayle appointing Bob Oberlander, so I want to officially enter this correspondence into the record. Bob is now a member of the Board; you'll see a little about him here as you can see his submitted resume. He has a background at Penn State in mechanical engineering and he is the CEO of Swiss Aero. Why don't I pause here for a moment – maybe we should have done this under the Director's Comments – and have Bob tell us a little bit about himself as a new member of the Board.

Mr. Oberlander: Sure. I have known Mr. Charlie Bayle most all of my high school and middle school career, I am married with four kids, I graduated from Penn State Behrend here in 1995 and started Swiss Aero with my brother a couple decades ago. I run that solely now and we make a lot of aero engine parts for (inaudible) in Jamestown and there are commercial applications too. I am also on the school board for Fort LeBoeuf, the food pantry, a member of the Kiwanis Club, and also of the Manufacturer's Business Association. I'm looking forward to meeting everybody.

<u>Dr. Wood</u>: Just so the Board knows, Bob and I have met and Bob has gone through his orientation as a Board member and I think he's fully up to speed.

I see that Doug Smith has joined us so I will make sure that is noted in the minutes. Thank you for being here, sir.

Continuing on in the Director's Report, you remember at our last meeting that we did approve \$250,000 to be a part of the Diverse Erie revolving loan fund; here is the advisory that went out on that. As a reminder, these are the groups that have partnered. We did participate in an announcement in front of Beez Appliance over on Parade Street as that is one of the businesses that will be receiving a loan from this loan fund.

As we scroll down, you will see some recognition we got in the Asbury Woods newsletter where they decided to make us sponsor of a few different events, then there's a thank you letter from the Humane Society for the grant we gave them, and then there are the news clippings. There is some coverage we got on the Investment Playbook from the Erie Reader, and then some recognition in the Corry Journal for the Renaissance Block Program. I always like to put our newspaper clippings in here so you can see how we're getting the word out about ECGRA.

Normally to get the word out, we use television and news as well as print media. We have social media campaigns, and of course we do press conferences, like the one we did in Edinboro on Tuesday of this week where we issued \$200,000 to Edinboro; \$150,00 for Mission Main Street and \$50,000 for the collaboration with Washington Township and the Borough of Edinboro for their parks plan.

One other thing I want to direct you to is there is a new report that ECGRA just published on our listening sessions from the summer. We took that information, we condensed it down to a five-page report, it's available on our website, ecgra.org. It was a rural listening tour, so we hit up North East, Union City, we did a joint meeting with Girard and Lake City, we did one in Corry, one in Millcreek, one with Edinboro, McKean, and Washington Township, and then we did one in Fairview. This report has bullet points detailing what we heard in the listening sessions, those in attendance including elected officials, business leaders, and 501c3 that have received or are in line to receive funds from ECGRA. This report tells us what the priorities of these communities are. Once again, that report is on the website. I'll pause there and take any questions you may have.

Hearing none, that concludes my report.

Mr. Barney asks Mr. Smith if he has any comments from the County Executive's office. Mr. smith's response is there is nothing to report.

SOLICITOR'S REPORT

Mr. Wachter: Thank you very much. I have been working with Dr. Wood on various questions throughout the course of the months. I just want to comment on something. I don't often have substantive reports to give at these meetings because the Gaming Authority has professionalized so many of the operations that there aren't many questions that come up. I just want to say that as a solicitor for a government body, and I have a lot of different clients, I appreciate the attention to detail, I appreciate the professionalism, and I appreciate the concern for the applications of the ethics laws and the conflicts of interest laws and the like. You guys do it right. You don't bring controversy on yourselves, you don't have unforced errors, and I just want to say, "Well done." I don't mind not having a lot of work to do for you guys because you're doing good work and you're doing fine. Job well done. I'm here if you need me, but good job.

Mr. Barney: We appreciate those kind words, Tim. Not often do people actually acknowledge when you're doing good.

OLD BUSINESS

There is no old business to discuss at this time.

NEW BUSINESS

<u>Dr. Wood</u>: I do want to say, Bob, normally there is at least one role call agenda item, like a resolution that we're passing, but this is just an off month between grant cycles. The next big grant cycle that's coming up is a small business ecosystem piece where we are supporting small business development in the region and that is due at the end of September. So, we will be reviewing applications and Tom and I will be getting summaries out to you. We've talked about having some of those folks do presentations to the Board, which we haven't done in quite some time. But we will let you know as we get closer.

There is no new business to discuss at this.

ERIE, PA (October 18, 2022) — Erie County Gaming Revenue Authority (ECGRA) reported on its findings from a summerlong "Rural Listening Tour" at an event in North East. In the report, ECGRA makes recommendations to position rural communities for success.

"As we wrap up reporting on the findings from our summerlong Rural Listening Tours, one thing remains abundantly clear, more resources are needed to take these impactful projects over the finish line." said Dr. Perry Wood, Executive Director, ECGRA.

ECGRA also announced an investment in North East leveraging local share gaming dollars to enhance the region. The Multi-Municipal Collaboration and Mission Main Street grants are working to advance North East's economic and community development goals grants as part of the Building a Better Future Transformational Grant funding.

Seven listening sessions were organized directly with grant recipients, municipal and civic leaders as well as industry and business owners designed to:

- a) provide the respective community with a summary of local share gaming revenue investments,
- b) conduct outreach and advise decisionmakers on the deployment of Building a Better Future (BBF) funding also known as ARPA funds; and,

c) solicit hyperlocal feedback from the respective community concerning ongoing projects of priority, shovel ready projects and aspirational projects.

The listening sessions unveiled a vast civic infrastructure fueled through a collective will to understand and access available ECGRA funding to advance the improvement of rural communities.

Members of County Council, a liaison to the County Executive's Office, a member of the Planning Department, and the Erie Community Foundation were invited to attend the sessions held in North East, Union City, Girard & Lake City, Corry, Millcreek, Edinboro & McKean, and Fairview.

Recommendations from the report are aimed at connecting rural communities by advancing necessary improvements. ECGRA is invested in the region's municipalities including North East, and this borough continues to show their investment in the region.

At the event, Downtown North East was awarded \$175,000 for their Mission Main Street grant program and the Borough of North East was awarded \$100,000 in the Multi-Municipal Collaboration grant program for a total of \$275,000 towards North East's economic and community development goals.

New and ongoing initiatives on Union City's project list

Some projects have been completed, others are ongoing and important new initiatives populate the "project update" list on Union City Borough's website.

The list, at unioncitypa.us/ progress, is designed to keep Union City's citizens apprised, and provides a community investment scoreboard of sorts that since 2009 now totals more than \$5.5

"My reaction is definitely excitement," said Borough Council President Riley Cross about the constantly evolving initiatives. "To see the amount of people and money investing their time into our town is a great indi-

cation of what's to come for our future as well."

The most recent changes to the project list include closing out three recent projects, although each of them is actually moving into new phases with the acquisition of additional funding by Borough Manager Cindy Wells.

One is completion of more than \$200,000 in residential property improvements, with costs shared by those property owners and the Erie County Gaming Revenue Authority's (ECGRA) "Renaissance" program. While that round of funding has been completely utilized, an additional round of \$100,000 in residential matching grants from ECGRA is being made available for the remainder of 2022 and 2023.

A second closed-out project is a \$65,000 feasibility study to construct a "French Creek Trail" through the borough, from Devereaux Park along Bridge Street to the American Legion Little League complex at the north end of First Avenue.

With the study completed, work to construct the first phase of the trail and related enhancements is anticipated in 2023. Just this week, the borough was awarded a \$91,240 grant from the Pennsylvania Department of Conservation and Natural Resources for that work, and is awaiting word on an approximate \$202,000 grant application to the Pennsylvania Department of Community and Economic Development.

That work, to include a parking area, pedestrian walkways and installation of new playground equipment, is expected to take place in 2023.

 A significant sidewalk improvement project through PennDOT that targets walking routes to Union City Middle-High School on Concord, Bridge and Willow streets. That project is anticipated to take place in late 2023 or early 2024, funded with \$875,000 in PennDOT funds and \$87,500 in local matching funds.

"It's been exciting to see all that we have been able to accomplish in a short amount of time," Wells said. "These are projects that people are able to notice.

"The projects that we have pending are very large and will provide the community some major improvements that wouldn't be possible without the grant funding," she added.

Riley Cross said the wide variety of work is noteworthy.

"I think tackling projects on a wide range goes to show the investment is being made to the town as a whole and not just one place," he said. "I believe as more residents see this, it will get them involved, and excited as well."

Cross said it can be difficult to convince residents of any community that positive change is occurring, and that local government and organizations can actually make a difference.

"There will always be people that have a better idea, think we are focusing on the wrong things, or wasting money," he said. "But I think as more people get involved, and as more projects get completed, they will see just how much has been accomplished from where we were just a couple years ago."

Davis' pledge of relief funds for project draws scrutiny

Erie County Executive Brenton Davis has pledged millions of dollars in federal COVID-19 relief to a single manufacturing center he believes will spark greater investment in the region.

But in order to make good on that pledge, Davis wants to divert funds from a transformative



grants program that has been supporting hard-hit communities for a

Brie County Council members Mary Rennie, Andre Horton and Terry Scutella say the pledge

violates the spirit of the American Rescue Plan, which was to provide immediate help to those most affected by the pandemic.

They also say Davis made the pledge unilaterally, with no public hearings, no public votes and no regard for the process and procedures of county government.
"It's not even a rubber stamp, it's a rollover," Rennie

said in regard to Davis' approach to council.

At a Sept. 15 meeting, Davis officials asked council to support a resolution to green-light the use of Amer-ican Rescue Plan funds toward the proposed center. The resolution was tabled after Rennie, Horton and

Scutella said the administration was merely seeking council support after already committing funds to the project.

On Thursday, the finance committee agreed by a 4-3 straw vote to add the resolution to the regular council meeting agenda for Oct. 4 as a first read. Rennie, Horton and Scutella, all Democrats, were the nay votes.

Davis eyes Penn State Behrend project

The pledge in question involves \$5 million in American Rescue Plan money that Davis wants to go toward the development of a manufacturing and engineering center at Penn State Behrend's Knowledge Park.

The \$5 million makes up a local match for a state Redevelopment Assistance Capital Program grant of \$8 million. If awarded, the RACP grant — on top of the local matches from the county and Penn State Univer-

sity — could provide the project roughly \$16 million. The center is the first phase of Project RESOLVE and is one of 15 projects in Eric County competing for a RACP grant. It's the only one that Davis Is supporting with American Rescue Plan funds.

In a statement, Davis said the new center would es-tablish the region as a "global leader in battery research and testing," and make the area a magnet for employment and investment, especially at the Wabtec Corp. plant in Lawrence Park Township.

He said using the \$5 million was a "logical approach" since the money was part of an existing budget line, Transformative Grants, in the 2022 American Rescue Plan budget.

Rennie says Davis is "playing favorites" among the potential RACP contenders and has committed funds to the center — before seeking council approval — to bolster its chances of getting the RACP award.

Funds were to help community projects

Speaking with the Times-News, Rennie said the Transformative Grants budget line was intended for the Erie County Gaming Revenue Authority, which received the first round of this funding in 2021 and has a grant process in place to support critical community

Davis officials said the money was fair game because the 2022 American Rescue Plan budget did not specify the Gaming Revenue Authority as the recipient of the funds

"If ECGRA doesn't have control over it, then that doesn't automatically mean the county executive has control over it," Rennie said. "In other words, if we didn't name a fiscal agent, all that means is council needs to name a fiscal agent for that money. The county executive does not have complete authority to go in any line of the budget and just raid it for his own purposes."

Perry Wood, executive director of the Gaming Revenue Authority, said he expected to receive the \$5 million and had conducted "organized rural listening sessions" in the summer to determine what projects needed support.

"It would be a shame to see that funding directed away from transformational grants to communities like Millcreek, Girard, Corry, North East and Union City," Wood told the Times-News. "The County Council has been put into a very difficult position being asked to choose between their constituents and a single pro-

Wood said the listening sessions showed an "urgent need for investment" in dozens of projects, from water lines and broadband in Girard to sewer service expansion throughout the borough and township of North

"It's projects like those that would be left unfulfilled," he said.

While Rennie, Horton and Scutella each voiced their support for Project RESOLVE, they questioned whether American Rescue Plan funds are the appropriate funding source.

"I think the money can be used for basically what it was meant to be used for," Scutella said. "There's still people and other organizations that are hurting and I think it would be better to use it for them."

Council solicitor says Davis violated charter

At a Sept. 15 finance meeting, County Council Solicitor Tom Talarico said Davis had "usurped" the council's authority by pledging the funds without approval He also said if council approved the resolution to support the use of American Rescue Plan funds, it would be "breaking the law every bit as much as the county executive."

"He, on his own, usurped the County Council's au-thority and pretended that he had the authority to get involved and influence Wabtec, Behrend, RACP, the government - all giving them the Impression that that money has been appropriated already, Talarico said of Davis. "He has no authority to do that. He is completely out of line.

Horton questioned why the council's three-person ad hoc committee - formed in July to recommend changes to the 2022 American Rescue Plan budget had not reported back to council on the matter.

County Information Officer Chris Carroll, in an email to the Times-News, said Davis had met with the ad hoc committee on multiple occasions and the committee had "indicated support of this commitment to Project Resolve."

However, ad hoc committee members Brian Shank and Jim Winarsk! said they were unclear about any such commitment.

To the best of my recollection - no," said Shank of the ad hoc committee backing the \$5 million pledge

Winarski said, "I would say people liked the idea but

I don't know if there was ever any commitments.'

Schauerman, the third member of the ad hoc committee, could not be reached for comment.

Rennie stressed that if the resolution passes, then County Council is "rolling over" for the county exec-utive. If it falls, the county will be "on the hook" to find funds elsewhere, she added.

Penn State Behrend, Davis deny fund pledge

In an emailed statement to the Times-News this past Tuesday, Robb Frederick, Penn State Behrend's assistant director of news and information, said no one has pledged funds toward Project RESOLVE.

No officials, including the current county executive, have at any point made any promises of funding for this project," Frederick said. "It has always been our understanding that any allocation of local funding for the center would require the approval of County Council. We recognize and respect the council's role in this process.

This past Thursday, Davis told council members that any allegations that he committed funds or made any deals with Penn State Behrend on Project RE-SOLVE were "fictitious."

However, Davis and his director of administration, Doug Smith, have acknowledged in a statement and at a council meeting, respectively, that \$5 million in American Rescue Plans was "pledged" to the project.

Documents obtained by a Right-to-Know request from the Times-News also indicate that Davis on Aug. 19 emailed the Erie County General Authority - which submitted the RACP application on the county's behalf and wrote that "Erie County will invest \$5 million in Project Resolve from our ARPA funds" and that "PSU has agreed to match the \$5 million," and that these funds were "agreed upon."

The RACP grant application, submitted on Aug. 19, indicates a local match of \$8.4 million - which includes the \$5 million investment.

Bid to re-budget rescue funds fails

Council blasts the lack of detail in Davis' plan

Since taking office in January, Erie County Executive Brenton Davis has sought to repeal and replace a massive COVID-19 relief plan approved by his predecessor.

On Thursday, his first serious at tempt at a replacement fell short.

In a contentious two-hour work session, Davis clashed with members of Erie County Council over his proposed re-budgeting of \$26.2 million in American Rescue Plan money awarded to the county.

Davis, whose administration developed the new budget with a three-person ad hoc committee, consisting ocuncil members Brian Shank and Ellen Schauerman, both fellow Republicans,

and Jim Winarski, a Democrat, said the proposal was merely a "framework," designed for council to agree on areas of investment as opposed to specifics on who exactly will get the money.

Council members Mary Rennie and Andre Horton, both Democrats, blasted the lack of detail and said they wouldn't commit to any budget without more information. They also said Davis was more keen to prop up new industries as opposed to serving hard-hit minority communities. "The American Rescue Plan was intended for those most negatively impacted by the COVID-19 pandemic," Horton sald, "and it was also supposed to help those demographics who've been historically impacted — and that would be Black and brown people."

Davis accused Democrats of grandstanding and using stall tactics to delay his efforts to build partnerships.

"i don't know how we can seriously

communities of Black, Indigenous and People of Color.

The commission was allocated to receive \$3.5 million as part of its second round of Rescue Plan funds.

The Rev. Dwane Brock, bishop of the Victory Christian Center Cathedral in Erie, who attended a council finance meeting immediately after the work session, said Davis was demonstrating "insensitivity" toward marginalized communities

"Obviously, he doesn't recognize it, but if he does recognize it, he's just ignoring it," Brock told the Erie Times-News. "It's a travesty to humanity and a travesty to poor people in the minority community within Erie, Pennsylvania, and Erie County, and he ought to be ashamed of himself for it."

Geunty Director of Administration
Doug Smith and County Information
Officer Chris Carroll declined to comment on the matter Thursday.

The budget also eliminates funding for an urbah renewal and community development budget line, as well as an entrepreneurship budget line.

New investments included the Beehive Network, Lake Erie Watershed Protection, county re-entry services, general community investment projects and education technology grants. The budget maintained funding for the Erie County Community College and the Homeless Project Grant program.

Davis said part of his vision was to leverage Rescue Plan dollars toward projects like Project RESOLVE at Penn State Behrend, with its focus on plastics, and Project Neptune at Gannon University, with its focus on water-quality testing, and tap into what he called a multi-trillion-dollar Great Lakes economy.

"Put those two projects together, that
essentially makes us the epicenter for
water pollution, plastics pollution (research and testing)," Davis said. "I think
this is, merely a catalyst for larger returns."

Horton reminded council that it passed a \$531 million county budget in 2021 and that "we probably spent less than \$1.5 to \$2 million on communities of color."

"All these shovel-ready projects — it looks like the rich are going to get richer, and those who have the capacity to put forward stuff quicker or have the grant writers," he said. "It doesn't appear to me that a lot of thought has been given to the American Rescue Plan's mission of impacting those communities and demographics most affected by the pandemic."

seek any kind of community partners when we don't have a serious commitment," he said.

While council unanimously agreed to not move the budget forward and to have more work sessions, the stand-off between Davis and Democrats revealed what has been — and what will be — a central question surrounding the use of Rescue Plan funds in the county. Should the money be used on long-term and potentially lucrative business projects or serve the Immediate needs of those most affected by the COVID-19 pandemic?

Davis pushes generalities, Democrats want specifics

The \$26 million represents the second half of a \$52-million pot of Rescue Plan funds awarded to the county. Both halves were unanimously budgeted by the former County Council in 2021 and approved by then-Eric County Executive Kathy Dahlkemper.

Davis has argued the second half was hastily budgeted as Dahlkemper prepared to leave office and that his administration should have an opportunity to revise it. He's also said the U.S. Treasury released new, more expansive guidelines in April and allow for Rescue Plan funds to be used more broadly, and potentially toward his economic development priorities.

In July, council formed the ad hoc committee to study these guidelines and recommend any budget changes to council. The committee met four times, each time with Davis in his office, according to a statement from the administration and Shank.

The proposed budget Thursday was considered a potential ordinance for the Oct. 4 regular council meeting, as requested by the administration.

But council members, including Horton, said this was the first time the full council saw the budget.

"The seven of us collectively have not had time to digest or even peruse this," he said.

Rennie said the proposal was severey lacking details that were present during the budgeting of the first round of Rescue Plan funds in 2021. She insisted the administration provide supplemenary documentation and exhibits that treak down every bureau and program ecciving funds, as well as descriptions and plans of action for each.

When we sign our names to these

ordinances and resolutions, they become law," Rennie said. "We bear the weight. Our one signature is really signing for tens of thousands of people that we represent and that's why it's so important to know what we're signing and that everything we sign is backed up by written rationale. These aren't suggestions, this is the way council operates."

Davis said the ad hoc committee was only meant to develop a budget plan of "generalities," a basic framework of investments that council could agree on and commit the \$26 million toward. He said once the money is committed, it will be easier to build partnerships and find leveraging opportunities.

"Counties that can't allocate and move progress forward aren't going to be as competitive as countles that can," he said.

He added it would be an "egregious abuse" of taxpayer dollars for the administration to fill in all the requested details only for council to reject the proposal

Rennie responded by saying "that's (the county executive's) job."

Proposed budget eliminates diversity commission funding, focuses on business 'clusters'

ECGRA brings \$250,000 in grant funds to Union City

County rejects Project RESOLVE

Erie says no funds for Penn St. project

Erie County Council shot down a resolution Tuesday to use COVID-19 relief money toward the development of a manufacturing and battery-testing facility at Penn State Behrend.

In a 4-3 vote, the council's four Democratic members — Mary Rennle, Andre Horton, Terry Scutella and Jim Winarski — voted down the measure, which would have greenlit \$5 million in Amer-

ican Rescue Plan funds toward the proposed center at Knowledge Park.

While all four Democrats said they supported the center itself — which Penn State Behrend called its first phase of Project RESOLVE, a 10-year regional strategy to strengthen the competitiveness of local manufacturing — they woiced concerns about the legality of the transaction. Namely, whether the pro-

ject was eligible for Rescue Plan fund-

ing.
"What is legal and what isn't?" Winarski asked his colleagues. "Can we
use the money for this or can't we?"

Winarski, who told the Erie Times-News on Monday he would support the resolution, changed his position

Tuesday, insisting he had too many unanswered questions.

Horton and Scutella argued that Rescue Plan funds were intended for communities most negatively impacted by the COVID-19 pandemic. Horton added that Penn State University was already a significant "money-making institution" and didn't need county funds, whereas minority communities, the homeless and at-risk county residents did.

Rennie, Shank clash over county executive's influence over council

The meeting's most heated exchange involved Rennie and Council Chairman Brian Shank over the role of Brie County Executive Brenton Davis.

Rennle questioned the process by which Davis brought forth the resolution, insisting he pledged the \$5 million toward the project — and privately met with certain council members to secure votes — before discussing the matter with the full council body.

"This money was promised before we ever stepped foot in this room," sald Rennle, who has argued that Davis often blurs the line between his office and council.

The comment set off Shank, who said Rennle was grandstanding and making false accusations.

"Nobody on this council walks around with votes in their pockets," he sald. "Everyone of these (council members was) duly elected by the people and we make decisions on why we vote."

Turning to Rennie, he said, "So for your grandstanding, name-calling that you love to do, it's inappropriate and it will not happen again in this chamber that you say just whatever Mary Rennie wants to say however she wants to say it."

When Rennie said Shank made a "personal attack," followed by Horton stating Shank was out of order, Shank banged his gavel and threatened to "clear the room" if members infringed on his speaking time.

Rennie said she was referring to the Davis administration — not council members — with votes in their pockets.

"I think everyone understands that," she said.

Legal opinions vary on use of Rescue Plan funds

Central to the resolution's failure was the question of legality: Was it legal to use Rescue Plan funds for Project RE-SOLVE?

County Solicitor Bill Speros said it was "absolutely legal," during a recent council meeting. That opinion was shared by Matthew Hanson, a member of Witt O'Brien's, an international crisis and emergency management company that serves as the county's consultant on the Rescue Plan funds.

Hanson on Tuesday said a pathway to eligibility was proving to the U.S. Treasury that a local business or industry impacted by the COVID-19 pandemic could benefit from the proposed center.

He said the Davis administration selected the Wabtec Corp. plant in Lawrence Park Township because it suffered at least an 8% loss in employment during the pandemic and met the job loss threshold stated in the Rescue Plan guidelines.

Councilwoman Bilen Schauerman voiced confidence in the consultant's assessment, saying Tuesday "they are well aware of what is allowed and what isn't allowed in the ARPA guidelines."

However, former County Council Chairman Carl Anderson disagreed.

Speaking at Tuesday's meeting during the public comment period, Anderson, who helped spearhead the budgeting of the 2022 Rescue Plan budget, read aloud an excerpt from the U.S. Treasury guidelines that stated "large capital projects intended for general economic development or to aid impacted industries" were ineligible for Rescue Plan funds. He said the Behrend center should be funded through eligible means, like revenue replacement, as opposed to taking money away from the Brie County Gaming Revenue Authority, where the \$5 million was originally intended.

County Council Solicitor Tom Talarico similarly pushed back on the county's consultant.

"ARPA monies are not supposed to be used for this purpose — it's completely inappropriate," he said. "There's nothing wrong with using any kind of county money if it's available to satisfy this. But it's a complete violation of the ARPA law to use ARPA money for this particular register."

The Davis administration sought the \$5 million as a local match for a state Redevelopment Assistance Capital Program grant of \$8 million.

Prior to any council approval, a RACP grant application for the project was submitted in August by the Brie County General Authority on behalf of the administration and Penn State Behrend. The application indicated an \$8 million local match, which included the \$5 million.

Speaking during the public comments period Tuesday former County Council Chairman Piore Leone blasted Davis for committing funds before council approved them.

"I supported that county executive," Leone said of his endorsement of Davis in 2021. "But they do put erasers on pencils when you make mistakes. I'm not saying it's entirely true yet. I'll wait to see what he does in the future."

Davis and Penn State Behrend have denied making any commitments of funds toward Project RESOLVE.

What's next?

Following the meeting, County Information Officer Chris Carroll, who reggesented the administration at the meeting, said he was disappointed in the outcome.

"We feel that the investment into plastics, the investment into that industrial battery-testing facility, is a one-of-a-kind project," he said. "It's going to be the first of its kind in the nation and we need to start investing in ourselves. We're disappointed in the outcome, but it's not going to deter us. We're going to continue to fight for Project RESOLVE

and we'll see what's ahead "

Rennie sald the project is "up to Penn State at this point."

"We don't know yet how much or even whether they will get an award from the RACP grant application," she said. "The question of public or private funding matches, I think will be a future conversation and not only one for County Council."

Penn State Behrend could not be reached for comment Wednesday.
