Minutes of the Board of Directors' Meeting October 19, 2023

Meetings for the Board of Directors of ECGRA can begin meeting in a physical location per Governor Wolf's proclamation of June 11, 2021. However, each member and ex-officio has the option to attend in person or virtually. Members of the public can now speak at the physical location of 5240 Knowledge Parkway.

CALL TO ORDER

The Board of Directors' Meeting of the Erie County Gaming Revenue Authority was held on October 19, 2023 at 5240 Knowledge Parkway, Erie, PA 16510. Legal Notice of the meeting was given through an advertisement appearing in the Erie Times-News. The meeting was called to order by the Chair at 8:30 am.

ROLL CALL

Mr. Barney, Mr. Cleaver, Mr. DiPaolo, and Mr. Oberlander are present in person. Ms. Hess and Ms. Loll are present via zoom. Mr. Smith is present via zoom (enters meeting late). Mr. Wachter and Dr. Wood are present in person.

APPROVAL OF THE AGENDA

Mr. Cleaver makes a motion to approve the agenda. Mr. Oberlander seconds the motion. There is no discussion of the agenda. Motion carries 6-0.

<u>APPROVAL OF MINUTES</u> – September 2023

Mr. Oberlander makes a motion to accept the minutes as presented. Mr. DiPaolo seconds the motion. There is no discussion of the minutes. Motion carries 6-0.

DIRECTOR'S COMMENTS

Mr. DiPaolo: Perry, in regards to the buyback for the guns, I see in the newspaper last week that ECGRA had an opportunity to do this back in 2013. And after a review they denied or didn't want to do it. Was there a reason why this wasn't done? And who made the determination that it wouldn't work?

<u>Dr. Wood</u>: So, the staff did do research on gun buybacks. It was shown to be the least effective intervention in the United States as far as gun buybacks goes. According to, and you're testing my memory here, but it was national research centers that are funded by the federal government that found that was just completely ineffective. So, those were peer reviewed studies that were done. The board did take a vote on whether or not to move forward with it and the Board voted not to.

I do want to say I wasn't interviewed for that story. No one talked to us about it, the specifics. Because you're right, it was 2015. It was a long time ago. But we wouldn't typically comment on something that another program or another elected official was proposing if it didn't involve us. That was just historical information that was interjected in that news story.

Mr. DiPaolo: Okay, so the information that you received not to do it came from who, though? That said that they don't work - who basically said that?

<u>Dr. Wood</u>: You're really testing my memory here. I'd have to go back. There were national centers that researched. . .

Mr. DiPaolo: The only reason why I'm asking you, and I know that I read the articles . . .

<u>Dr. Wood</u>: Hold on a second. They were national centers of research on gun violence, and all of them concluded that it was an ineffective intervention.

Mr. DiPaolo: Okay. Boston, Chicago, New York, California and Florida all have these. They have them regularly, so I don't know where this inform . . . I see here that he's got it quoted in here that a professor from John Jay College said that they don't work.

<u>Dr. Wood</u>: We even had a retired county detective come in and talk to the board about how ineffective they were.

Mr. DiPaolo: Retired County detective, I don't know, was he ever a cop that worked the streets? Or you don't know?

Dr. Wood: I don't remember.

Mr. DiPaolo: Okay. I just was kind of curious. I thought that, I think it's a good idea. In 1994 when the city had it, I was involved in that and it took almost 700 guns off the street. And they got two guns that were involved in a homicide. So, I mean, there is a plus to it. There's no doubt about it. Okay, thank you.

COMMENTS BY THE CHAIR

Mr. Barney has no comments at this time.

PUBLIC COMMENT

There are no members of the public present, so there are no public comments at this time.

PRESENTATIONS

a. Bridgeway Capital - Dawn Seckler

<u>Dr. Wood</u>: We have an update from Dawn Seckler, who is from Bridgeway Capital. Dawn, I'll go ahead and turn it over to you if you want to reintroduce yourself to the Board.

Ms. Seckler: Good morning, everybody. Thanks for having me. My name is Dawn Seckler. I'm Director of Development at Bridgeway Capital. And just to jog your memories, you have provided us with exceptional grant support and program related investments over the year. We are a nonprofit and a social impact lender with an office in Erie. The report this time is really quite robust. I'm really excited to share with you everything that we have going on in Erie.

The first bit that I want to share is that TJ King, who is the lender that opened our Erie office about 10 years ago, we have rehired, and he is back in that role. TJ has a tremendous network of connections with a variety of stakeholders in the region. And we can see that in the short time that he's been back in this position, he's really growing our lending activity and our pipeline. So, while some of the deals on our pipeline are still very much in the exploratory stage, for the first time in a really long time, we have a pipeline well over \$5 million for Erie. We recently closed a loan to the Ye Ole Sweet Shop and have another loan that has recently closed to a small corner store owned by an immigrant gentleman that provides culturally relevant food for folks who keep a halal diet. So that's fantastic news.

We have also hired an additional person on a part-time basis. Her name is Janessa Norton and she's going to work with us as a business assistance specialist, which means that she'll be providing financial and business advisory services to our clients in Erie. Janessa has an incredible amount of experience helping many small businesses and we had gotten to know her through her work with Erie's Black Wall Street, Paramount Pursuits, and some other programs that we have been running up there. She has a Bachelor of Finance with a concentration in Managerial Accounting from Mercyhurst University.

Our business education programs, for which you provided us a \$200,000 grant, are going very well. We have about seven minority contractors in our Building Inclusive Development program. We did a tremendous amount of work to identify these seven contractors. I think building our reputation and trust and getting to know more people in that space is going to help us continue building the number of individuals who are enrolled in that program year after year. Through that program, the contractors are really learning about - not their trades, that's what they know - but their business fundamentals: how to make sure that they're operating a business that has the strong potential for financial stability and growth.

We're also working with a group of creative entrepreneurs in our Erie Made program, and that also is going very well. I'm excited to share with you that your grant has really helped us increase the access to additional grant funds, so Bridgeway received its first ever grant from the Erie Community Foundation. When we applied to ECGRA, we applied for the full \$250,000 and understandably you're able to support us with \$200,000. So that \$50,000 grant from the Erie Community Foundation filled that gap in our budget to run those two business education programs, Erie Made and BID - or Building Inclusive Development.

And very excitingly, we were able to leverage both of those grants, and have secured a federal grant. I'm extraordinarily proud of it. We were one of only 43 grant recipients from across the country to receive a Minority Business Development Agency grant. It's an agency from within the Department of Commerce. It is a four-year grant for \$2 million and these funds will be used by Bridgeway to run a variety of cohort-based business education programs around the geographic service area that we serve. But certainly, a good portion of them will be used to extend our ability to continue running the program that you all have funded in the years to come.

I will pause there and would be very happy to answer any questions you may have.

<u>Dr. Wood</u>: Dawn, this is Perry. I'll just say for the record that Bridgeway Capital has been the most prolific partner that we've had in supporting and growing small business in our region. Over the years, multiple programs cultivated starting with the Erie Growth Fund. Later on, the Erie Inclusive Fund, which was groundbreaking for its time. And then during the pandemic, loans to both nonprofits and businesses before all the government intervention kicked in, like the PPP and other stuff; Bridgeway Capital was right there to partner with us. And now with some of the entrepreneurial services being offered in your location at the Erie Center for Arts and Technology.

I just want to commend you; you've been a tremendously valuable CDFI for us to have in the region.

Ms. Seckler: Thank you. We're really grateful for the partnership. We couldn't do it without you all.

<u>Dr. Wood</u>: Thanks for being with us this morning. We appreciate it.

Ms. Seckler: My pleasure. Have a wonderful rest of your meeting. Thanks everybody.

COMMITTEE REPORTS

a. Treasurer's Report: Mr. Cleaver: Thank you, Mr. Chairman. I reviewed the expenses; in my estimation, everything is in order. If the Board has any questions, I'm sure we can answer them. Other than that, I would recommend that we accept the financial report.

Mr. Oberlander makes a motion to accept the Treasurer's Report as presented. Mr. DiPaolo seconds the motion. There are no questions or discussion of the Treasurer's Report. Motion carries 6-0.

b. Strategic Planning Committee

There was no meeting held, therefore there is nothing to report.

REPORT OF THE EXECUTIVE DIRECTOR

<u>Dr. Wood</u>: Good morning, everyone. Here's your letter from the Commonwealth Department of Revenue, which has funds coming into the region; you will see it reflected in our Balance Sheet. This is the official notification that we get once a quarter, as well as the County. Secondly, you have a report from Parker Phillips on our communication strategies; something for you to take a look at. We were quite busy this month with Infinite Erie activities. There's a current meeting agenda, looking over portfolio companies. And we continue to cultivate that relationship with the other funders.

This is something that we funded. It was the PA Route 6 Alliance Conference; the PA Route 6 goes all across the country. The Pennsylvania portion is pretty big piece of that and includes Corry, Union City, and Edinboro area. They had me as a guest speaker and here is a little information about what I spoke about at that conference. There's an article about the Corry to Erie portion of the Pittsburgh to Erie trail and how we've contributed to that. That's Joy Fronzoli, their County Planner, that we've worked with on this project over the years.

Then there's the sale of Bliley Technologies. I wanted to get into that and highlight that because I think it's a particularly big win for the community and I want to talk to you about the role that ECGRA played in it. This is the Mission Related Investment we did with 1855 Capital; first time we ever invested in venture capital. November of 2017, a long time ago; looking at Tim here that was a while ago that we put that together. But this is the due diligence on 1855 Capital, these are all the closing documents, these are the meetings leading up to it. You don't really know what's going to happen when you make an investment in a group like that, and a half a million-dollar investment is a big deal for a group of our size. But we felt very strongly that a Venture Capital Group with an economic development mission was important to the region.

They've looked at several deals over the years, but this is the big one. Bliley Technologies, if you didn't read it in the newspaper, is a local manufacturer founded in the 1930s. They make crystal oscillators which are very important in technology for mobile communications. So, your cell phone, satellites, a lot of military equipment, things like that. Bliley had been chugging along and surviving mostly off the government contracts they had because they're at the high end of the oscillator market. But they were struggling, and 1855 Capital bought them out because they saw the value of their assets, particularly the 20 patents that they held. Then they shopped around for local investors; they found several and eventually got bought out by KYOCERA, which is a multinational corporation based out of Japan.

So just to put it in perspective, Bliley was about a \$7 - \$8 million company, and they got bought out by a \$15 billion company. Now, in the past, you'd look at it and you'd say, "Well, that's not an economic development win; what if those jobs leave the area?" The fact is, the engineering talent that was there is so incredible, that KYOCERA is actually adding a new division in the United States and basing it here in Erie because of this purchase. So, whereas they had four divisions, now they have five. I mean, they're employing 80,000 people worldwide. They fully expect that that \$7 - \$8 million investment is going to grow between \$50 and \$100 million within the next five years. And they're going to build a brand-new facility right here at Knowledge Park. So, it's a huge win. It's a huge win for the region, and we had a very small part in it because we invested in 1855 Capital.

1855 Capital is a Seed Stage Capital, which means it is higher risk; it's more on the high-risk side. But as we looked at our impact investment statement, or our strategy to invest in groups like this, this was an alternative investment that fit perfectly with what we do. 1855 Capital is heavily affiliated with Penn State. Ben Franklin Technology Partners, which is also affiliated with Penn State, was a major investor. And then if you read the article, you'll see there's other local names like Chancellor Ford, who were investors in the program as well.

It was a group of folks from Penn State, as well as some property managers that negotiated with the Japan based company. And they kept that negotiation secret for 18 months. They had mentioned it to some of us but in such sparse details; we didn't have company names or anything like that. Now they're going to build a 50,000 square foot facility.

I highlight this because we often don't talk about these wins in our community, and they're huge wins because this is a global company. And advanced manufacturing is, if you look at data, advanced manufacturing, we have a high location quotient, which is what economists would say shows that you have an advantage in a certain sector. So, it's a tremendous win. I wanted to highlight it with you. We played a small role in it, but we should be proud of it. Any questions about Bliley or KYOCERA or 1855 Capital?

Ms. Loll: Perry, that half a million, was that a grant or a loan?

Dr. Wood: It was an investment in the form of a loan.

Ms. Loll: Okay, thank you.

Mr. Wachter: I'm trying to think, because it was a while ago, what's the trigger for payout on that? When the Fund closes?

<u>Dr. Wood</u>: When the Fund closes is the trigger for payout. When you invest in a Venture Capital Fund, your capital is locked into it. They make their investments and then this is known as an exit event. So, Bliley is sold, money goes back into the Fund, the Fund grows, and then the Fund closes at the 10-year mark. So, in 2027 there will be a payout. We would actually make money on our investment in this case.

Mr. Wachter: Just so people understand how that is calculated in terms of the loan, the Gaming Authority is not permitted to own equity in a commercial entity. But these funds had no interest in coming to Erie whatsoever because there was no investment going into these funds. So what we did is we worked with the Commonwealth Financing Authority; when I say worked with them, we largely modeled our approach after what the Commonwealth Financing Authority did, to loan money to this Fund and others and have the interest rate calculation be what our equity piece would have been in the Fund had we bought equity. The payout for the entity for anybody who would have taken equity, what their payout would have been, we back into a calculation as to what the interest is and have a principal return and a balloon interest rate payment at that final exit event when the Fund closes. So, we don't have equity ownership, but we have stake in the Fund similar to what the equity would be.

Mr. Oberlander: What triggers the Fund to close?

<u>Dr. Wood</u>: When the offering document comes out in the beginning when they're looking for investors, it has terms like that. It states when it's going to open, when it's going to close, here's the minimum they're going to raise, here's the maximum they're going to raise. It raised about \$10 million dollars. That's actually a small growth fund.

Mr. Wachter: There are three or four Funds floating around out there that are operating that we'd made similar investments in and this is the one that has been the most . . .

<u>Dr. Wood</u>: Blue Highway is the only other one because we never made an investment in the Harrisburg–based one.

<u>Mr. Wachter</u>: You're right. We talked about it but we never did. PVP Penn Venture Partners, we never did that. But the only reason these funds came to Erie, largely one of the only reasons these funds came to Erie, was because of the availability of that funding from the Gaming Authority.

Mr. Barney: So, we're looking for a return on this?

Mr. Wachter: We're looking forward to a return. So long as the remainder of the investments that they make between now and 2027 are still good.

<u>Dr. Wood</u>: So, there's the article in your packet and then wrapping it up with a nice article here about the streetscape funding that we did in downtown Erie. Which was several years ago, but just now getting implemented. Any questions for me?

Ms. Loll: Perry, were all those investments done in 2017? Do you have a list of those?

Dr. Wood: Investments for what?

Ms. Loll: I understood from the conversation there were more investments other than just this company? Am I correct?

<u>Dr. Wood</u>: Oh, yeah. 1855 has an entire portfolio that they've been investing in. This is the big Erie win.

Ms. Loll: Do you have a list that ECGRA did?

<u>Dr. Wood</u>: Sure. Are you asking if ECGRA invested in other things in 2017, or you want to know who 1855 is?

Ms. Loll: Well, not just 2017 but in that manner?

<u>Dr. Wood</u>: So take a look at the finances real quick. Because it's all right there. The Balance Sheet, under Notes Receivable, those are all the investments that ECGRA has made.

Ms. Loll: Okay. See, I didn't understand that that's what those were.

<u>Dr. Wood</u>: Yes. So that's why they're under the category of Assets. So you see, like I talked about this morning - Bridgeway Capital (BWC), EDF is Enterprise Development Fund, 1855, Progress Fund, Blue Highway Capital, and Erie Center for Arts & Technology. And the loan we have with Youth Leadership Institute. They're all listed right there.

Ms. Loll: All right. Thank you.

Dr. Wood: You bet. Does anyone else have anything for me? Thank you.

Mr. Wachter: Doug Smith would like to be admitted.

Let the record show that Mr. Smith enters the meeting at 8:56am.

Mr. Barney: All right. Welcome, Mr. Smith. We're going to continue and I'm going to get you in for your comments in a minute, okay?

SOLICITOR'S REPORT

Mr. Wachter has nothing to report at this time.

OLD BUSINESS

<u>Dr. Wood</u>: I'd like to ask the Board to make a formal motion to appoint myself to the Fly Erie LLC Board. Last month we awarded funds to that concept. We're going to need a representative on that Board. Unless the Board feels strongly that a member of the Board should be appointed to it, my recommendation is to just have your executive director sit on that Board.

Mr. Barney: Well, I have no problem with it. Are there other Board members who have comments on that? We do need a representative on the Board.

<u>Dr. Wood</u>: If someone on the board has a tremendous interest in doing this, I recommend that you do it or that we go together. If not, at the very least, we have to have a staff member on there.

<u>Mr. Cleaver</u>: I think it's a great idea because our positions change after X number of years. Every time you turn around this one's gone and that one's gone. So, I think it's a good idea for you to do that.

<u>Dr. Wood</u>: Bob asked how many board members do they appoint? I don't know the answer to that. It's going to be based on the investors in the Fund. Right now, it looks like it would certainly be us, since we approved it, Erie Insurance, the airport, the Chamber. I actually haven't followed up with them to see how these other investments have gone. Erie Insurance is the only one I know of for sure.

<u>Mr. Wachter</u>: In order to do that, under the Old Business section, we will need to make a motion to amend the agenda to add that particular item and then do the motion to appoint somebody. So, you would do a motion to amend the agenda to add an appointment to the Fly Erie LLC Board, second for that, all in favor - that goes on the agenda. And then you can make the motion to appoint whomever it is you want your representative to be.

Whitey makes a motion to amend the agenda to add the appointment of a representative from ECGRA to be on the Fly Erie Board of Directors. Ms. Hess seconds the motion. There is no further discussion or questions on this motion. Motion carries 6-0.

Mr. Wachter: Okay, now you have a new agenda item on your agenda. And so it would be the appointment of a representative to the Fly Erie Fund. So, if someone would like to make a motion and attach a name to it, that would be in order.

Mr. Barney: Before I do that I want to find out if anyone on the Board at this time have a willingness or a desire to be appointed to that Board? I hear none.

Mr. Cleaver makes a motion to appoint Dr. Wood to the Fly Erie LLC Board of Directors. Ms. Hess seconds the motion. There is no further discussion or questions on this motion. Motion carries 6-0.

Mr. Barney: Now we have someone on the Board keeping an eye on our funds that can report to us.

NEW BUSINESS

There is no new business at this time.

Mr. Barney: Mr. Smith, do you have any comments at this time or anything you would like to share with us?

Mr. Smith: Thank you, Mr. Chairman. I just wanted to update the Board and say good morning to all of the team there. The County has continued its meetings with EMS and other officials on the project of creating a County Authority for EMS. It is clear through the research that our potential partners have revealed that they are not interested in an Authority that the County itself controls but one that they in fact populate on the Board and that is a point of agreement for us. Coming up in November, and I'll send these to Tammi so she might distribute these to all of you, there are going to be a series of public meetings at high schools in the area; November 8th at Fort LeBoeuf, November 9th at Girard, the 13th at Millcreek, the 16th at Iroquois, and the 28th at the Erie County Library. There will be discussion about the proposed model that has been worked on by Strategy Solutions, Deborah Thompson's firm. That committee, which includes John Orr from Stancliff Hose, Dan Oulette from Millcreek Township, David Basnak from EmergyCare, Bill Vassen from Cranesville, Ron Boll from McKean, and Steve Oler from Harborcreek. That committee continues to meet and will be on hand for those public meetings.

We feel like progress is being made. There is being discussion about a potential fee that this Authority might be able to levy if it is formed under the legislation that is currently in the que in Harrisburg. That fee, if it were created, would replace any sort of millages that communities are leveraging now for EMS services. We feel like it continues to move forward. We appreciate the Board's continued open-mindedness on this topic and we'll continue to do our best to keep you informed of our progress. And I will send you those dates so that if you're interested in attending one in your area, you'll have the opportunity to hear what's said and hear it firsthand rather than hearing it from me.

With that, I guess that's all I have. I did ask your team for a breakout of the \$4 million in Transformational ARP money that was awarded in 2021 and the breakout of the \$737,000 in Beehive grants that was awarded last year. I'm sure that information will be forthcoming. We've already created an ARPA map that shows us where funds have gone and what they were used for, and I would like to have this information to continue that particular project and knowledge of just what was done with the Beehive grant. With that, I thank you for the time.

Mr. Barney: Thank you, Mr. Smith. Are there any questions for him?

Ms. Loll: I just wanted to make sure that the information that he asked for that he also receives.

<u>Dr. Wood</u>: Doug, I have a question. The Senate bill that's going to allow for a County Authority to leverage an EMS fee, is that supported by Senator Laughlin?

Mr. Smith: My understanding is yes.

Dr. Wood: Fantastic. Thank you.

Mr. Smith: The County Executive met with the Chairman of the Senate committee on this project, Senator Mastriano. That was a good meeting and they agreed to move that item forward. I can't tell you at this time but I'm more than willing to get back to all of you on more specific details of what may have come out of that meeting. Since I know someone in Senator Laughlin's office, I'll find that out too.

ADJOURNMENT

Mr. Oberlander moves to adjourn. Mr. DiPaolo seconds the motion. Meeting is adjourned at 9:08 am.

An ACH for the 3rd quarter of 2023 payment in the amount of \$2,975,283.29 should be deposited in your bank account within 5 -7 business days. This payment includes the slots local share assessment of \$475,283.29 and the slot machine license operation fee of \$2,500,000.00. Any reductions to the Gross Terminal Revenue (GTR) for promotional items is the result of the Gaming Bulletin 2015-01 and the Pennsylvania Supreme Court's April 28, 2014 decision in Greenwood Gaming and Entertainment Incorporated v. Commonwealth of Pennsylvania, Department of Revenue (90 A.3d 699 (Pa. 2014)).

ERIE, PA (November 9, 2023) — The Pennsylvania Department of Agriculture awarded the Minority Community Investment Coalition (MCIC) Grow Erie project a \$50,000 reimbursement grant through the Urban Agriculture Infrastructure Collaborative Grant this month. These funds will work to advance the first-of-its-kind project at Savocchio Business Park located on Erie's eastside.

The Grow Erie project is an equitable economic development project establishing controlled environment agriculture in one of the poorest census tracts in Erie County.

"Feeding health and economic prosperity in our cities feeds us all," said Pennsylvania Agriculture Secretary Russell Redding. "Urban neighborhoods are vital to Pennsylvania's future, and funding innovative, local coalitions like MCIC and Grow Erie multiplies the impact of state investments. The Shapiro Administration is committed to investing in strengthening local economies, promoting food security, and reducing effects of climate change to improve quality of life and health in urban communities."

Through the Urban Agriculture Infrastructure Grant Program, MCIC will use funds to purchase and install the INTAG Nutrient System. The INTAG Natural Nutrient System (INNS) is a proprietary, aerobic biodigester that allows for waste-water and associated sludge material from the Recirculating Aquaculture System to be utilized as a natural source of nutrients for plant cultivation in the Hydroponic Greenhouses. This technology decreases the amount of waste-water being discharged from the fish farm, and decreases the use of conventional, chemical fertilizers in the greenhouses, making both facilities cleaner and more environmentally friendly than conventional operations.

"The investment from the state shows the meaningful vote of confidence as we work to revitalize a 15-year vacant lot and begin the generational transformation of Savocchio Opportunity Park," said Shantel Hilliard, executive director of the Booker T. Washington Center and co-founder of MCIC. "Our Grow Erie project will create sustainable income to reinvest in high-need neighborhoods, provide employment opportunities to low-income residents, and bring a source of locally-grown food to a USDA-designated food desert.

"We thank the state for their support and look forward to continuing our work with them as we improve the lives in Erie's poorest zip code."

Grow Erie, which officially began construction last week, consists of two distinct facilities at Savocchio Opportunity Park. Once developed the project will positively impact about 20,000 residents in need.

- A 17,000 square foot commercial facility where fish and plants will be grown using a system of aquaponics. This high-tech greenhouse will operate 365 days a year, and will supply C.A. Curtze Company with market-rate, locally grown fresh greens, micro-greens, live herbs, and rainbow trout.
- A 2,500 square foot community greenhouse will be open to local residents and offer a variety of raised beds for growing produce. The accessible, year-round greenhouse will contain the necessary equipment for ensuring food-safety and the production of clean, healthy food for distribution through neighborhood farmer's markets.
