Minutes of the Board of Directors' Meeting May 16, 2024

## CALL TO ORDER

The Board of Directors' Meeting of the Erie County Gaming Revenue Authority was held on May 16, 2024 in the Board Room; 5240 Knowledge Parkway; Erie, PA 16510. Legal Notice of the meeting was given through an advertisement appearing in the Erie Times-News. The meeting was called to order by the Chair at 8:31 am.

# **PRESENTATIONS**

a. Ms. Marybelle Martin – GECAC

<u>Dr. Wood</u>: Just an introduction for everyone, this is Marybelle Martin from GECAC here to give us an update on Summer Jobs. Summer Jobs is on the agenda to be passed today. It's one of the last things Doug Smith did before he left was to reach out to us about Summer Jobs.

Ms. Martin: Let me start with a thank you for the monies that you put into the Earn & Learn program. Every bit that we get helps train this new generation that we have in the workforce. My son is 19 and he's part of the Earn & Learn so again, thank you for the money that you give us to run this program; it is very well needed. Thank you for starting your morning with me; my name is Marybelle Martin and I'm the manager of the Education Workforce and Self-Sufficiency division at GECAC. Earn & Learn is one of the programs under my supervision. I have some familiarity with the program, first of all, because I've been the division manager since late August of last year. I missed a lot of the transition period, but I was able to pick up the end of that in September through December when we had the 20 youth who were continuing to work post summer employment. And I'm also a mom of a son who did it.

My son worked there under Summer JAM in its former incarnation, and he worked there under Earn & Learn and I have to tell you the professional skills he learned under Earn & Learn – and I'm 100% serious when I tell you this – made all the difference in the world. He goes to Penn State. He's in charge of the Bold-C, if you're familiar with that group. He also works at CAM Erie from time to time so he's a techie kind of kid, a film kind of kid. When he was working with Earn & Learn he had a summer job as a lawn mower and field grass maintenance person at Gannon. When he got the job with Earn & Learn last year, he was put in an office in charge of people and his phone skills improved immensely because he's of the "text me" generation. His phone skills improved immensely; his confidence improved immensely. So, I'm going to maybe reference him a couple times during this presentation because he's 19 now and we're talking about that workforce, which is approximately born in 1997 to 2012 which makes them between 12 and 27. So you know he's smack in the middle that generation, but I tell you that also because we have more work to do with this generation; they're young, they're the text generation, they're the COVID generation, they lack social skills and they will tell you that and they lack confidence and they know that.

So, what I'm going to do is give you a brief history of Earn & Learn, talk to you about what our mission is, then I'll go into some of the three top issues that hiring managers have with this generation. I will tell you what we're doing to prevent that or address those issues. Then I will close with some fast facts about Earn & Learn 2024, and then I'll answer any questions you may have.

<u>Dr. Wood</u>: Let me just pause for one second and recognize that Ms. Hess has joined us on Zoom. So I'm going to recognize her as present in the attendance record. Sorry, go ahead.

Ms. Martin: Thank you. The overview – our Earn & Learn program provides job readiness training, career exploration and employment opportunities for youth living in Erie County. The program aims to expose them (youth and young adults) to local industries and businesses that can absorb them as full-time employees. And that kind of harkens back to what I said about my son under Summer JAM, which was a wonderful program. He worked in the fields, he worked in the grass, he did maintenance. Under Summer JAM, he became an office person and his communication skills, both verbal and oral or written just improved dramatically and his confidence grew, which I did not know he had a confidence issue until he started working in the office and was talking on the phone to people he did not know.

So, Earn & Learn, as you know, is a collaborative effort between the Erie County government, Erie County Gaming Revenue Authority, GECAC, and other supportive individuals and organizations that have recognized the need to address employability issues for our disconnected youth population 14 to 21 specifically. I mentioned Generation Z which is again from 1997 to 2012 and we're kind of right smack in the middle of that generation. We want our youth to not only gain job skills, but also have the opportunity to explore career paths that lead to full time employment in their field of interest. And that is a difference I think that I'm seeing this year and the end of last year. Before we had just a program to get the kids off the street and have them working. Now we have a program that looks to kind of give them the tools they need to interview and the ability to explore new career interests that allow them to go out and develop a career. So, they're not just working for a wage now, they're working toward a career in whatever field they choose. Huge difference to my son. Huge difference I think to our youth.

So, what are the challenges? I mentioned soft skills are huge, and this generation, they know it, experience, and work ethic. Lack of soft skills; I have some facts here for you regarding a Harris Poll, of 1,200 workers 82% of them stated Gen Z needs more guidance time and training. Remember this is the COVID generation, the tech generation. Three out of four managers state that it's more difficult to train this generation in soft skills than in tech skills. And you can see why I pulled that information. A couple of facts for you regarding that and I bear witness to the fact that that is true within our community. They know what they need. I remember when COVID hit I was working for GECAC in a different capacity, and I remember Erie High students - they were given the tools they needed to get the work done during COVID but they did not all have access to Wi Fi. So, I would drive down Cherry Street or the neighborhoods around there and see them huddled around somebody's house that had Wi Fi and was willing to share the signal so they could get their work done. They want to learn. They absolutely want to. We have to give them the tools they need. I understand that was some of the millennial generation but it's also a lot of Generation X.

The second thing that hiring managers across the country have identified is a lack of experience. Eighty percent of hiring managers across the nation said they worried about Gen Z's lack of experience as a younger generation. And again, COVID and there are a number of things that factored into that, but I can see for myself in Erie County that is true.

Lack of work ethic and this is tricky because I know what they say - this generation - I know what they say to me, but across the board and across the country 58% of hiring managers were worried about this generations unprofessional attitude and 63% expressed concern they were known to job hop. That's true. Approximately one in two hiring professionals question this generation's reliability and work ethic. So unprofessional attitude, by and large, post 2023 season, what I heard from most hiring managers was that they did not understand when the youth had downtime, why they went on their phones. Because we were taught - and I'm 56 - we were taught that if you had some down time you go look for something to do, you go ask the manager or the director whoever supervises you what else you could do to further

your position in the company or what you can do to just add value to why you're there. This generation, once they have some downtime, immediately turn to the screen, and I've seen that in my own house. So, here's some stats for you and I'll let you read them for a minute.

<u>Dr. Wood</u>: I wonder sometimes how much is generational and how much is they're just young people.

Ms. Martin: That's a great point. The key word I see right there is mentorship and that is why I put that quote up there because that's one thing I understand about our youth, and to hearken to Perry's comment about generational - I remember reading back in the 1780's Marie Antoinette's mother wrote a letter to her complaining about the lack of respect in the youth and a lack of work ethic because they were not learning their needlebook, their embroidery, whatever math they learned at that time, their music, art, dance lessons; they didn't want to do it. So that's a comment that's been carried throughout the nation. I'm sure that every parent everywhere has said something like that, so your point is well taken.

Here's how we respond. GECAC, ECGRA, the County here's how we respond to this. We respond by mentoring, job coaching, and of course soft skills development. We lead by example. Mentoring is a huge, huge thing to me knowing what I know about our youth today. While a manager might criticize an employee who is underperforming or micromanage them to ensure they stay on task, the advice for this generation is to lead by example. This approach coupled with soft skills training, mentoring and coaching can provide this generation with the skills they need to analyze their own behavior and find solutions to get the job done. Captain Chris Cusson, here in Erie, I don't know if you know him, but he was the captain of the Lettie G. and as such, we were talking about putting students into the Earn & Learn program under his supervision. One of the things he said to me, and this is going back a year ago, was that he loved the idea of putting a 16 year old onboard on deck with a 60 year old and having them work together to sail that ship and asking questions and the older one might be mentoring in some areas and the 16 year old might be mentoring in some areas. But the point is they work together and ask questions and learn from each other. And that has stuck in my mind ever since he said that because that's exactly what we like to do right here.

So, soft skills are critical. They're critical. As the slide pointed out earlier with the hiring managers saying that you can teach tech skills, you cannot teach soft skills in the workplace. So that's our job. That's what we try to do. Here's the soft skills that we try to model, train, and teach. The ability to handle constructive feedback is a tough one. Sometimes when you tell people that they're not doing the job correctly, they fall apart. We teach them to absorb it, correct, and move on. Problem solving skills, critical thinking is key, conflict resolution, time management, again, going back to the idea that when they have downtime, they're on their phones, public speaking, which they know they're not great at and leadership skills. This is where we partner with Erie County Career Pathways Alliance's Career Street, Career Link, Gannon, Erie Insurance and other successful former Earn & Learn youth. We bring them all into our orientation and I'll give you the dates of the orientation a little bit later in the presentation. We bring them in to speak; Mary Bula comes in and trains them on workplace do's and don'ts. We have speakers from Erie Insurance come in and train them on professional behavior in the workplace. Former Earn & Learn youth come in and talk to them about their experience what they had and how Summer JAM. I think that this program started at GECAC in 1965 and it was called NYC at that time. Mr. Jones was actually part of that youth program, and he mowed lawns for \$2 a day so our successful Earn & Learn youth employees will come back and speak to our youth about how the experience helped them.

<u>Dr. Wood</u>: Okay. Can I pause you for a second? There are some new board members, so I want you to know that we've been funding this for eight years, so we understand how it's structured. And we typically allow about 15 minutes for a presentation.

Ms. Martin: Am I running over already? I'm sorry.

<u>Dr. Wood</u>: No, that's okay. I don't want to move it along if the board members are enmeshed in it today. I just want to make sure that we might have a few questions to ask if we have time for that.

Ms. Martin: I totally understand; thank you for keeping me on track. Mentoring is key - onboarding and ongoing mentoring is key and if you would like me to make this available to you after I'll be happy to do that for questions.

Dr. Wood: That would be fantastic.

Ms. Martin: Job coaching matters. We job coach. My point in saying all this is to let you know that the monies you're funding for us are going toward these things to address the issues I mentioned previously. This is how we're doing it.

Some goals - again, employment. There is a limit of 150 youth, skill development, career exploration, job readiness, networking, and personal development. Fast facts - there are two tiers, which were implemented last year; fantastic idea. Tier One employees ages 14 to 17, Tier Two employees ages 18 to 21. We're recruiting 100 people in the city, 50 in the county, if we get more fantastic. Program staffing is 1) program assistant, 2) youth counselors and a director and myself in some capacity. Wages: tier one employee start at \$8.25 an hour after 45 days and a successful review they move up to \$8.50 an hour for the last 45 days; tier two the same at \$10 and \$10.50 an hour. And after the six weeks are over, this is one more piece I want to just bring to your attention, we don't just drop them off and say, "Hhave a good school year." We refer to area programs. We're going to schedule a resource fair at the end of the season so we can bring in other community organizations that might be of interest to these youth, any nonprofits we have, any other employment partners that are interested in carrying these youth forward into the following season into the fall season; we're going to do this resource fair. We're going to do more transfers, we're going to make sure that they get where they want to go. Question?

<u>Dr. Wood</u>: The big evolution of the program is a two-tiered system. And the two-tiered system is based on age but also the sophistication of the experience. Just touch on that for a moment because we're being asked to - you may not know this - we're being asked to put an extra \$50,000 a year into this program above what we actually do and that's part of the justification is this two-tiered system.

Ms. Martin: Tier one are the youth ages 14 to 17. They come into this with no experience. They're part of that Gen Z I talked about and they're needing the soft skills and those types of early job characteristics that help them become employable. So, a lot of work has to go into training, teaching and modeling, mentoring for those you so the tier ones are the ones who need the most hands on that. That is why we're putting forth or front loading the effort on to them. Tier two are the people who were either in the program before or we assume that they've had some sort of job experience at ages 18 to 21. They're presumed to have some understanding that when they're on the job they're responsible for doing the job and not being

on their phones. We're assuming they come into the job with some sort of experience, soft skills included, and they need less hands-on experience or less hands-on training or mentoring or modeling from us. So that's the difference between the two tiers.

Mr. Barney: Tier two - they don't necessarily have to have been in the program before. So we're bringing in 21 year old for the first time?

Ms. Martin: Yes, sometimes yes. If they present with some job experience.

<u>Mr. Barney</u>: Okay, because that wasn't initially, when this was started, that age group coming in for the first time. Okay, and then my other question is, you spoke on your son, you know, landscaping jobs, there's nothing wrong with those jobs.

Ms. Martin: There is nothing wrong with them at all.

Mr. Barney: To me, those starting in should want to work. We should want them to work those jobs to see where they want to go. In other words, if you don't know about cutting grass and sweating you have no idea that that's not what you want to do to motivate you to possibly go to college, or prepare yourself for the office job that your son experienced. "Oh, I like this side rather than that so let me go to Behrend." I was just wanting to make sure we didn't get so big or so good that no longer are we offering kids who just want or need - because this was based on need too as far as family. They may need to be cutting grass getting a paycheck, to be able to help out.

Ms. Martin: I apologize if I gave that impression to you. We do have like Erie Insurance will hire people right now to mow the grass and do landscaping too. So, my intention was to focus more on the career piece of that and by doing so I did not give enough value of weight to what you're speaking about. And that was my communication error and I apologize. You are correct.

Mr. Oberlander: How do you recruit students? Are they any financial need go to the higher or it's just strictly . . .

Ms. Martin: We do look for students who are zero to 150% of federal poverty level. We go to the schools, we send out information via social media, we talk to people who have hired in the past. Many of our parents contact us before the program even begins. So, we have multiple ways of going out. Last week I was out Girard hanging flyers and talking to business owners to make sure that they were aware we had this program. So, we recruited in a number of different ways.

Mr. Cleaver: What's your approximate number of individuals you're going to get into this program? Do you have an idea what you're looking for?

Ms. Martin: We're looking for 150 total. Right now we have 180 youth applications. And if we get 180, if they follow through and give us all the paperwork we need, and they show up at the orientation and make sure that they're there, then we will take 180 youth. We will take whatever we can get because the jobs are there.

Mr. Barney: The job breakdown - you said 100 in the city and 50 in the county.

Dr. Wood: We've always shot for 50-50.

<u>Mr. Barney</u>: Okay. I was under the impression and I also have inside sources, who told me that more jobs are being created from county sources. So, we would be closer to reaching that goal. But if not, I mean, as long as we're striving toward what the goal was.

Ms. Martin: We actually have Corry as a base for us to use. I've been out in North East speaking with people out there. I'm a person-to-person kind of relator. We have jobs out in Albion as well, that we're working with. There's a gentleman farmer who wants five hay balers and I'm going to get him five hay balers. So we are in North East, Corry, Albion, we're working in Girard and Fairview as well. So yeah, we're trying to expand in the county because it is Erie County Earn & Learn, not Erie City Earn & Learn. Of course the majority of the people are centered in the city, but we're really making a concerted effort now to get into the county as well.

<u>Mr. Barney</u>: Okay, this is my last one. but this extra \$50,000, is it going up because we're giving them the two-tier wage thing? Or is it because we're paying additional professionals to monitor them, to nurturethem, to train them? I mean, where's the breakdown on that?

Ms. Martin: I think it's a little bit of both, but from my perspective, it's more of the staffing that we're using it for. Because before, this was a single person run program with assistants, and then under Summer Jam, which was great, we had a director and then an assistant. Now we're really looking to expand and with 180 applicants, we're going to need extra staffing. And we're going to need extra staffing, not just because they're applying, but we want to follow through with them. We want them to come into the program. So, let's say 150 youth want to work. We're going to follow up with them to make sure that they come into the program. But if they don't come into the program we want to know why.

Mr. Oberlander: So, if there was an employer in Waterford that was looking into this program, what qualifies them as an employer, do they come out and research the actual company?

Ms. Martin: We do. We make sure, number one, that they have their clearances; that's priority if they're working with youth under 18. They need Act 33, Act 34, and FBI clearances to even go near youth under 18. We want to make sure that the jobs they have could potentially lead to a career. If you know if the youth is older, we make sure that the job is something that they can do safely. We don't want them handling heavy machinery. Hay baling is different. Throwing hay bales on a truck is different than actually mowing. We don't want them doing that. We want to make sure that the employer understands that this is a job for the youth. I mean the employer benefits for sure, but we want the youth to get work experience, real life experience and to learn those skills that we talked about here. So, the employer just can't bring them on and say this is what you do from two to four and then walk away. This is a mentoring type of environment. We mentor and the employer mentors. Thank you for the question.

Dr. Wood: Does anyone have a question on Zoom?

There are no participants with any questions for Ms. Martin.

<u>Dr. Wood</u>: Have you selected an agency to do an independent review or an evaluation of the program?

Ms. Martin: I haven't gotten that far yet.

<u>Dr. Wood</u>: Please let me know when you have. We have seven or eight years' worth of evaluations. We do take a look at it the office; it's very important historical document for us. It gives us an idea of how the program is trending.

Ms. Martin: Sure, I will let you know. And again, I apologize for going over my time. I get really excited about this program. It's a beautiful thing.

Dr. Wood: You did a great job. Thank you.

Ms. Martin: I hope I answered all your questions. With that, I will pack up and go.

<u>Dr. Wood</u>: Thank you very much, Marybelle.

Ms. Martin: Thank you.

Mr. Cleaver: Are there any other questions being asked in reference to this? No? I will acknowledge that this is on the agenda for New Business as a resolution.

# **COMMITTEE REPORTS**

# a. Treasurer's Report

Ms. Amatangelo: Thank you, Mr. Cleaver. So as everybody knows, we're only about a month into the new fiscal year so when meeting with Dr. Wood this week, I didn't have any major questions that I went over with him. But of course the Profit & Loss and Balance Sheet are where you would expect them to be a month in. I personally prefer the Budget vs Actual just because it's going to give us more detail related to our Profit & Loss, specifically our expenses. And just looking there, nothing is coming near budget, everything's under budget. And again, that's what I would expect a month in.

I'll point out on the Schedule of Grant Reserves that the first quarter disbursement, so April, \$1.3 million went out and Tammi did include kind of a detail of the disbursements; if you guys want to look at that I recommend it. Moving on to the Transaction List Detail again, just a detailed list of our expenses - what you would expect to see payroll, insurance, grant disbursement, no phone bills, mileage, things that we're all used to seeing. And then of course, we went over the Visa and the visa bill included what you would expect coffee, office supplies, there was a \$238 charge at UPS and that was just the ECGRA Works signage around the county and you see it, it's all over at different buildings and whatnot that ECGRA has supported. Amazon, already said it was office supplies and coffee. That's really it for the first month. Are there any questions?

Mr. Barney makes a motion to accept the Treasurer's Report. Mr. Oberlander seconds the motion. There is no further discussion on the Treasurer's Report. Motion carries 6-0.

# b. Strategic Planning Committee

<u>Dr. Wood</u>: We met yesterday, and we reviewed the 29 Community Assets; 25 of which the Board has said yes to move forward with funding. In fact, that's Resolution Number 11 on the agenda today.

We also saw a presentation from Daria Devlin on the Apprenticeship Trades for Construction model, which is going to implemented by the Hamot Health Foundation and held at the Erie Center for Arts & Technology. I think it was a fantastic presentation; I think that everyone that was there had a really good reaction to it. I would be more than happy to hear your reaction on record to it. I know various iterations of the Board have seen this presentation before but this was kind of the culminating presentation to say, "What are your funding gaps?" There are already two other funders in the program, but there is a \$229,000 funding gap. That's over a two-year period to get this thing up and running and that's what the ask is for. I know this is very aggressive, but we put it on the agenda as Resolution Number 12. But everyone in the room for the Planning Committee gave thumbs up and said that the Board should move forward with it. Are there any questions?

Mr. Cleaver: That's a two-year program, right?

Dr. Wood: That's a two-year program.

Mr. Barney: When you say questions for you, questions pertaining to that resolution?

Dr. Wood: I can try to answer them, yes.

Mr. Barney: Is that \$229,000 each year or total?

<u>Dr. Wood</u>: That's the total amount. The reason it's two years is because at the end of two years they will achieve a certification through the Department of Labor which will make them eligible to participate in apprenticeship funding through the DOL. So, this truly is gap funding; this is what ECGRA is designed to do – to provide seed funding and gap funding to get people able to stand on their own.

Mr. Cleaver: It was very well presented yesterday for the group that was there. The gal put all the cards on the table, and I think it's a great program. I think the majority of us did.

<u>Dr. Wood</u>: I will say there were a lot of good questions asked and answered and information supplied. It was a great presentation.

We also talked about our next Strategic Planning Committee meeting which Tammi and I are going to try to spin out in the next few weeks; that would include a presentation from Grow Erie which is the main revitalization strategy at Savocchio Business Park as well as a joint presentation between Gannon and First Ascent, which will look at a cancer screening technology new to the region and the potential for us to support a biopsy lab down at the I-Hack Center. We'll talk more about it then.

Mr. Barney makes a motion to approve the Strategic Planning Meeting. Ms. Amatangelo seconds the motion. There is no further discussion. Motion carries 6-0.

# REPORT OF THE EXECUTIVE DIRECTOR

<u>Dr. Wood:</u> I'll be brief. Dale loves it when I say that. Obviously, the staff spent a lot of time this month working on Strategic Planning and getting the Community Assets up and running for you all. You'll see a memo in here from the Administration; we had a meeting with the Administration, Mr. Barney and Tim Wachter were there, and we talked a lot about the communications and how we present publicly since we're a County Authority. So, this memo is what came out of that. They would like the following sentence to be read into press conferences and press releases: "This project is made possible in part by Erie County government and administered through the Erie County Gaming Revenue Authority." It seems reasonable to me. Without talking to you, I did respond and say that it was reasonable and that we'd be willing to do that. Does anyone have any questions on that?

Next is the summary of the work that Parke Philips did this month; if there are any questions, I can answer those. Then there are a couple of thank-you letters - one from the Edinboro University Foundation and the other from the Mercy Center for Women just thanking the Board for making the funding available and telling us about the good work they are doing. I wanted to make sure the Board saw those.

## SOLICITOR'S REPORT

# c. <u>Bi-Annual Performance Reports</u>

- (i) Bi-annual reports shall, at a minimum, indicate the following information pertaining to loans made pursuant to this Agreement:
  - job creation/retention attributed to loans made pursuant to this Agreement;
  - list of loan recipients by organization's name & contact person, or, if loan recipients object to public disclosure of their financial relationship with Bridgeway Capital, an anonymous but unique identifier and a non-identifying description of the recipient;
- (ii) Performance reports shall be provided to ECGRA until such time that Bridgeway Capital has loaned all of the funding provided by ECGRA pursuant to this Agreement, the Credit Agreement and the CDFI Note, and, until such point, shall be due on or before February 1<sup>st</sup>, and August 1<sup>st</sup> of each year.
- d. <u>Final performance report.</u> Within 60 days of the Agreement Term or Termination (whichever is earliest), a final report shall be submitted containing all information included in the bi-annual report along with a summary of the final portfolio balance indicating how Bridgeway Capital met program objectives. The final performance report shall, at the request of the Executive Director, be accompanied by a presentation to the ECGRA Board.
- 6. ECGRA Grant in Event of Default by Bridgeway Capital Debtor. In the event a third party defaults (the "Third Party in Default") on a loan made by Bridgeway Capital pursuant to the terms of this Agreement (the "Sub-Note"), and after Bridgeway Capital undertakes commercially reasonable efforts to collect such outstanding debt from the Third Party in Default, the outstanding principal balance of the Sub-Note related to such debt in default and owed by the Third Party in Default, and reasonable costs of collection incurred by Bridgeway Capital, shall be forgiven by ECGRA to Bridgeway Capital (the "Forgiven Debt"). The Forgiven Debt shall be determined to have been a grant from ECGRA to Bridgeway Capital. The amount of principal of the unpaid Forgiven Debt shall be credited towards the total principal amount then outstanding under the terms of the Note between ECGRA and Bridgeway Capital. To initiate the transformation of the loan from ECGRA to Bridgeway Capital to a grant, Bridgeway Capital shall certify to ECGRA, in writing, the efforts made to collect on the debt and that the debt has been determined to be uncollectable. After such certification, if Bridgeway Capital collects on the debt in default, Bridgeway Capital shall remit total principal amount collected to ECGRA within sixty (60) days of such collection. For purposes of this Agreement, "commercially reasonable efforts to collect" shall take into account the financial condition of the borrower and the cost of collection, and shall not require legal action by Bridgeway Capital if Bridgeway Capital

concludes in its reasonable discretion that the debt is not collectable or that collection efforts would conflict with Bridgeway Capital's mission.

- 7. <u>Drawdown.</u> Bridgeway Capital shall submit to ECGRA a drawdown request on a weekly basis for the total value of each loan to be closed in the next week. The drawdown request shall be submitted no later than 12:00 p.m. on Thursday of each week (the "Advance Request"). ECGRA shall review each Advance Request, and once approved, electronically transfer the funds to Bridgeway Capital no later than 5:00 p.m. on Friday of each week.
- 8. Federal or State Relief. In the event that the federal or state government approves and issues a stimulus or other relief package in response to the COVID-19 national emergency, and such funds are distributed to Bridgeway Capital for the purpose of deployment to businesses and/or nonprofits, including those within Erie County, and the intent of those funds is to provide funding in a manner and for a purpose substantially similar to the funding provided by this Agreement, the CDFI Note and the Credit Agreement, ECGRA reserves the right to provide Bridgeway Capital with a ten (10) day written notice of cancellation of further distributions pursuant to this Agreement, the CDFI Note and the Credit Agreement. Any drawdown requests made by Bridgeway Capital prior to the issuance of the above referenced notice shall be processed by ECGRA.
- 9. <u>Default</u>. Failure to meet any provision of this Agreement shall constitute a Default by Bridgeway Capital. In the event of Default, ECGRA will shall utilize the Default procedures contained within the Credit Agreement and CDFI Note.
- 10. <u>Suspension and Termination.</u> If Bridgeway Capital fails to correct substandard performance and thus cure the Default within the period of time stated by ECGRA, the Agreement may be Suspended or Terminated at ECGRA's sole discretion pursuant to the terms and conditions of the CDFI Note and Credit Agreement.
- 11. <u>Cooperation.</u> Bridgeway Capital shall cooperate in every reasonable way with ECGRA to facilitate the purposes and intent of this Agreement. ECGRA shall cooperate in every reasonable way to facilitate the purposes and intent of this Agreement.
- 12. <u>Indemnification.</u> Bridgeway Capital hereby agrees to release, indemnify and hold ECGRA harmless from any claims, damages, losses, law suits, causes of action or demands arising out of the good faith provision of services by ECGRA hereunder, except to the extent that such claims, losses, lawsuits, causes of action or demands are based on the negligence, recklessness, or intentional misconduct of ECGRA and/or its agents, employees, and/or personnel.
- 13. Right-to-Know Law. The Pennsylvania Right-to-Know Law, 65 P.S. §§ 67.101 67.3104, applies to this Agreement. (the "RTKL"). Upon notification to Bridgeway Capital that ECGRA has received a request for records under the RTKL, Bridgeway Capital shall fully assist ECGRA in responding to the request. Such assistance shall include, at a minimum, providing ECGRA, within three (3) days, access to, and copies

2024 Special Events and Arts, Culture, & Heritage Grants total \$400,000

Erie, PA (June 5, 2024) – The Erie County Gaming Revenue Authority (ECGRA) awarded \$200,337.88 in 2024 Special Events and \$235,383.93 in Community Assets – Arts, Culture, & Heritage Grant Programs today, totaling \$435,721.81. The funds will be distributed to 70 nonprofits and municipalities across Erie County.

"ECGRA works by investing in the organizations that preserve and enhance Erie County's incredibly unique culture," said Perry Wood, Executive Director of ECGRA. "These local organizations keep Erie communities and visitors coming together, while fostering a sense of pride and place. These investments simultaneously boost our economic and community energy – keeping Erie the best place we know to live, work, and play."

The Special Events Grant Program, which funds up to 5% of events that take place within Erie County, promote the region economically and culturally. These grants are driving tourism, attracting talent to the region, and helping sustain Erie traditions that make Erie County a special place to visit and call home.

Asbury Woods, the host of the event, was a recipient of this round of special event grants.

"ECGRA's support of Asbury Woods events and trail improvement projects over the years have been instrumental to our mission to connect people to the natural world – Special event grants have helped us keep several community events free or very low cost to attend,"

said Jennifer Farrar, Executive Director of Asbury Woods. "Grants towards trails and parks projects have improved a trailhead south of our main entrance, and we are currently working on an ECGRA-funded project to digitize our trail map that will provide real-time location data as you walk the trails and dynamic interpretive information to enhance your visitor experience to Asbury Woods.

"We are grateful for the support to Asbury Woods and the hundreds of organizations and projects ECGRA has supported."

The Community Assets – Arts, Culture, and Heritage Grant Program is an investment that encourages entrepreneurship and innovation, enables communities to engage in creative placemaking, plays an integral role in attracting new residents and businesses by elevating the quality of life, and protects what is unique to Erie County.

WQLN Public Media, which runs The Chronicles, the immersive documentary series that takes a deep dive into what makes the Lake Erie region remarkable, both past and present, was a recipient of this round of arts, culture, & heritage grants.

"A multi-faceted show like WQLN's Chronicles would not be possible without the support of organizations like ECGRA," said Michael Berlin, WQLN Executive Producer of the Chronicles. "Thanks to ECGRA's contributions, WQLN is able to extend its marketing to various platforms so that we can reach a greater audience and make them aware of the show, while also helping the show's producing team to contract various local talent, so that the show can feature other creatives to help tell the stories and preserve Erie's history.

"Thanks to ECGRA's generosity, Chronicles is capable of paying it forward and provide Erie's artists a space to do what they love while helping to educate about the region we call home."

An impact investing organization, ECGRA's mission is to empower the nonprofit sector, municipal governments, and economic development agencies to revitalize Erie County. ECGRA is endowed with local share gaming revenue from the Commonwealth of Pennsylvania via the Horse Race Gaming Act. Local share gaming revenue is an assessment of the licensed gambling industry in Pennsylvania. ECGRA administers Local Share Gaming Revenue Authority on behalf of Erie County government.

# Erie's summer youth jobs program starting 2024 season. How teens can apply

Connecting young people to local businesses and industries can play a critical role in building careers - and, in turn, boosting the local economy.

That's the philosophy behind the Erie County Earn and Learn program, a collaborative effort between county government, the Erie County Gaming Revenue Authority and the Greater Erie Community Action Committee.

The program, a retooled version of the Summer Jobs and More (JAM) program, provides job readiness training, career exploration and employment opportunities for Erie County youth throughout the year.

Erie County Executive Brenton Davis and GECAC Executive Director Danny Jones kicked off another season of the program Tuesday, informing the public that applications are now being accepted.

"This program is designed to tackle the shortage of workers for local employers while providing on-the-job opportunities for different youth and career pathways," Davis told reporters at the Erie County Courthouse.

"We believe in the importance of investing — one, in our youth, and (also) investing in developing our local industrial clusters and investing in opportunities right here in Erie County."

#### Who's eligible?

Participants must be Erie County residents, ages 14-21, whose family income is within 250% of federal poverty guidelines, according to GECAC, which administers the program.

#### What do participants do?

The program hosts 150 participants.

Tier 1 includes youth, ages 14-17, who have no work experience. This group will focus on job readiness training and soft skills like time management and teamwork.

Tier 2 includes youth, ages 18-21, with previous job experience or who are career oriented. This group will focus on existing career opportunities in Erie County.

Tier 1 participants will earn \$8.25 an hour. Tier 2 participants will earn \$10 an hour. In both cases, a successful evaluation could mean a pay raise.

"In previous years, many students have used these funds towards helping their families or helping themselves for school or school supplies," Earn and Learn Director Jamilia Gates said.

Youth are matched with employers based on employer specifications, geographic proximity and availability of reliable transportation for youth, according to GECAC.

Gates said jobs encompass a variety of sectors to include childcare, food service, community centers, receptionist work and helping small businesses.

Opportunities have also been available at Erie Insurance, Gannon University, the Inner-City Neighborhood Art House, the Martin Luther King Center and the Booker T. Washington Center, Gates said.

Since GECAC will now cover all wages, payroll taxes and worker's compensation for Tier 1 participants, more job opportunities might be available, Gates added.

#### How to apply?

Applications are available on the GECAC website at gecac.org.

The youth application deadline is May 31.

At the end of the application, applicants will have the ability to schedule an appointment with the Earn and Learn staff to complete the rest of their application.

# UC OKs 8 Renaissance Grants; application process reopened

Eight more residences in Union City Borough will get some sprucing up thanks to a Renaissance Grant provided by the Erie County Gaming Revenue Authority (ECGRA).

Borough Council, during its May 14 meeting, approved eight applications for Renaissance Grant funds.

All applications were approved based on the fact that improvements to the properties made with the funds will help in the borough's fight against blight.

The total amount of the applications was \$25,260.58. The money is from Round Two of a \$100,000 grant for the 2023-24 cycle.

"We have more than

enough money to cover this project," Wells said. "Approving these applications leaves about \$18,400."

The purpose of the Renaissance Grant Program is to remove housing blight, reverse deterioration, incentivize and spur private investment, make neighborhoods and communities more attractive, increase the market value of homes and improve the municipal tax base.

Because there is money left in the funds, applications will again be accepted.

"There are some funds remaining for the Renaissance Grant, so the application process has been reopened," Wells said.

Applications will be accepted for residential properties on West High Street, South Street, the Avenues, North Main Street, South Main Street, East High Street and Route 97 within the borough limits.

There are not any income requirements, but those requesting a grant must fill out an application. The application process is open and runs through June 21. The grant is made on a 1:1 matching basis, and the maximum grant award is \$5,000.

The following types of improvements are permitted: doors and windows visible from the street; roofs, soffits, gutters and downspouts; exterior lighting; porches, stairs and steps; painting, siding and shutters; and chimney and masonry repairs.



# Union Township "on the move" with purchase of new building

BY STRVE BISHOP Contributing writer After spending the better part of 70 years operating out of their current municipal building on Route 8 just south of the Union City Borough line, the Union Township 5upervisors have the township literally on the move.

The township late last year culminated nearly two years of negotiations with Texas-based Tetra Technologies by purchasing two buildings sitting on approximately 6.2 acres the oil-and-gas services firm had previously operated out of, but that had sat vacant in recent years. The property is only a few hundred yards south of the current township building, across Route 8 from Union City Elementary echool.

The \$200,000 purchase was finalized in November by the late Dennis Triscuit, a long-time township supervisor who recently passed away, and who referred to the newity acquired property as being the township's future "for-

The township was required to "match" the ECGRA grant with \$16,500 in local funds, and successfully applied recently to the Union City Community Foundation for half the match, or \$8,250. As a result, Union Township only has to provide the remaining \$8,250 to bring the initial pool of available renovation funds to \$66,500.

The township is already putting an initial slate of renovations together for the new building using those funds, and will expand the work scope when it sells the smaller adjacent building. That initial scope of work is expected to include plumbing, electrical, heating, drywall, paint and ceilings in what will be the new building's public space.

Renovations will also ultimately include expanding the size of the building's vehicle openings, including new garage doors, to accommodate the township's trucks, plows and other vehicles and equipment. While the new building's square footage is only slightly larger than the township's existing building, the configuration of that space makes it more easily usable.

The township supervisors will accept sealed proposals for the smaller building until its next meeting on Tuesday, June 11, at 7 p.m. The property's appraised value is \$103,000, and the supervisors at their recent May meeting rejected a purchase proposal of approximately \$65,000.

Township Supervisor Earl "E.J." Brown is making himself available to show the property to interested parties, and said the supervisors are hopeful for a quick sale that would fund sufficient renovations to the new building allowing the township to relocate before next winter.

"If we can get things shifted and get that additional funding (from selling the adjacent property), yes," he said of the goal to move in by winter. Brown can be reached at 438-2054.

Supervisors say relocation from the current township building will solve a number of longstanding issues, including that in order for the township's trucks and other the rear garage doors, those vehicles must swing over adjacent private property.

The township does not have sufficient space in its garage for all of its vehicles and equipment, meaning the township has had to lease off-site space. Not having all of its vehicles and equipment at one location reduces the township's operational efficiency.

The township also does not have sufficient space for all of its highway maintenance materials in one location, further reducing its efficiency. The current township building sits on approximately 1.5 acres, compared to the 5.4 acres connected to the new building. In addition, the township's current location is not secured by a fence, which has resulted in some past thefts of materials, while the new property is fenced.

Finally, the township's current office and meeting space is limited, and doesn't have restrooms compliant with the Americans with Disabilities Act. The new facility will provide for more suitable accommodations for election voting, provide potential meeting space for community groups, give the township the capability of providing an emergency shelter, and provide a more suitable space for an incident command center for emergency service providers when the need arises. It is those purposes for which the township received the ECGRA grant.

Brown said the township supervisors, which include Supervisor Chairman Brian Gregor and the recently appointed Chip Webster, are grateful for the support of ECGRA and the Union City Community Foundation.

"The community is very supportive," he said of the Union City area. "We are very, very fortunate to have these opportunities."

# WHO played a role in creating ECGRA?

The Pennsylvania Race Horse Development and Gaming Act was passed by lawmakers in 2004 to greatly benefit Pennsylvanians by ensuring gaming jobs and gaming revenue aid local organizations and residents.

Because of this act, Erie County receives 1% of the annual slot machine gross revenue of Presque Isle Downs and Casino and returns it to Erie residents — known as local share gaming revenue. Erie County government receives the first half for county government operations and the Erie County Gaming Revenue Authority (ECGRA) gets the second half to invest in projects and initiatives that invigorate Erie County's economy.

Multiple dynamic leaders in Erie County, including then State Senator Jane Earl, pushed to create an independent Public Authority to manage the funds. In 2008, Erie County Council established ECGRA.

# WHAT is impact investing?

The ECGRA Board of Directors are charged with administering gaming funds through municipal grants and serving as Erie County Council's economic development authority. In the first year, the board went straight to work and seized on that opportunity, creating real, meaningful, and lasting impact in our community.

In 2011, the ECGRA board hired economic development practitioner Perry Wood to serve as executive director. Wood was charged with innovating and bringing to fruition a framework that uses gaming funds for impact investment, grants and loans in Erie County.

Impact investing is intentional investing — working to create a positive impact and directly benefit communities – without the use of taxpayer dollars.

Following the lead of respected foundations across the U.S, in 2014, Wood and the board of directors adopted an Impact Investing Policy and began investing gaming funds to drive social, cultural, and environmental change, as well as reap financial returns that help ensure Erie County's local share gaming revenue gives back to local residents in perpetuity.

#### **RESOLUTION NUMBER 16, 2024**

A RESOLUTION OF THE ERIE COUNTY GAMING REVENUE AUTHORITY
AUTHORIZING THE FORGIVENESS OF CERTAIN DEBTS AND REASONABLE COSTS
OF COLLECTION INCURRED BY BRIDGEWAY CAPITAL, INC. FOR CERTAIN LOANS
MADE IN ASSOCIATION WITH THE FIRST AGREEMENT BETWEEN THE ERIE
COUNTY GAMING REVENUE AUTHORITY AND BRIDGEWAY CAPITAL, INC. FOR
EMERGENCY CORONAVIRUS COVID-19 LOAN FUNDS

WHEREAS, on March 25, 2020, in response to the COVID-19 pandemic, the Erie County Gaming Revenue Authority (ECGRA) entered into the First Agreement between ECGRA and Bridgeway Capital, Inc., for Emergency Coronavirus COVID-19 Loan Funds (the "First Agreement"), which encompassed a \$800,000 CDFI Note to Bridgeway Capital for COVID-19 Small Business Emergency Loan Fund and a \$800,000 CDFI Note to Bridgeway Capital for the COVID-19 Nonprofit Emergency Loan Fund (collectively, the "Emergency Loan Funds"); and

WHEREAS, the purpose of the Loan Funds was to provide loans to small businesses within Erie County that have demonstrated actual negative economic impact due to effects of COVID-19 and to provide loans to small Erie County nonprofit organizations for the purpose of providing them with resources to aid in their mission based local response to the pandemic; and

WHEREAS, Bridgeway Capital administered the loan funds by making subawards to eligible small businesses and small nonprofits; and

WHEREAS, Bridgeway Capital only drew down \$520,000 of funding for the Small Business Emergency Loan Fund and \$100,000 for the Small Business Emergency Loan Fund; and

WHEREAS, the Emergency Loan Funds were created at the outset of the Pandemic, and prior to any coordinated and systematic economic relief being provided to small businesses and nonprofit organizations by either the state or federal government; and

WHEREAS, at the outset of the pandemic, there were very real fears that many small businesses and nonprofits would have to close as a result of a lack of revenue generation due to state restrictions on the operations of such businesses; and

WHEREAS, when developing the Emergency Loan Funds, it was considered to be a very real possibility that a number of the loans would be uncollectable due to the recipients of the subawards closing their businesses or nonprofits as a result of the negative impacts of the pandemic; and

WHEREAS, to induce Bridgeway Capital to enter into the First Agreement and Notes with ECGRA, and to induce Bridgeway Capital to make subawards to eligible recipients in an uncertain economic environment, the First Agreement provided that, at such point that Bridgeway Capital "undertakes commercially reasonable efforts to collect" outstanding debts from any subawardees in Default, but makes the determination that the debt is uncollectable, ECGRA shall forgive the amount of such default (the "Forgiven Debt"); and

WHEREAS, the First Agreement provides that upon certification by Bridgeway Capital that such debt is uncollectable, ECGRA is to convert the amount of the Forgiven Debt from a Note to a Grant to the benefit of Bridgeway Capital; and

WHEREAS, Bridgeway Capital has certified to ECGRA that it has made commercially reasonable efforts to collect those certain debts identified on Exhibit A, in the amount of \$37,077.73, and requests that ECGRA convert this amount of Forgiven Debt from a Note to a Grant to the benefit of Bridgeway Capital; and

WHEREAS, the amount of the Forgiven Debt is less than 6% of the entire portfolio relating to the Emergency Loan Funds, represents .5% of the total amount of outstanding notes owed to the Authority, and is the only loan funds that ECGRA has ever been asked to forgive as a result of a default; and

WHEREAS, the Board of Directors of ECGRA agree that it is proper to covert \$37,077.73 of the Emergency Loan Funds, as are more fully described in Exhibit A, from outstanding notes owed to the Authority to a Grant to the benefit of Bridgeway Capital.

NOW, THEREFORE, this 20<sup>th</sup> day of June, 2024, the Board of Directors of the Erie County Gaming Revenue Authority, hereby RESOLVES the following:

- 1. The above recitals are incorporated herein as if more fully set forth.
- 2. The Board of Directors of ECGRA hereby approves the conversion of \$37,077.73 of loans made by Bridgeway Capital as part of the Emergency Loan Funds, as are more fully described in Exhibit A, from notes outstanding to a Grant in the favor of Bridgeway Capital.
- 3. That the staff is hereby directed to transfer \$37,077.73 from the Reserve for Uncollectable Notes to the General Fund to be redistributed by ECGRA as deemed appropriate by the Board of Directors.
